On June 29, 2018 the fire department received a call for a reported residential house fire. Initial reports were that all occupants had self-evacuated prior to fire department arrival. Upon arriving at the scene Captain Zidar established command and began to prepare for initial fire extinguishment. Shortly after arrival a resident advised Captain Zidar that there was an elderly female trapped in a back bedroom. Captain Zidar immediately took firefighter Smith and they transitioned into what is called a Vent, Enter, Isolate, Search (VEIS) technique. He further assigned the next incoming unit to take over fire extinguishment. Captain Zidar and Firefighter Smith moved to the rear of the house and located the window of the victim's bedroom. Firefighter Smith broke out the window and Captain Zidar entered the room/house without the protection of a fire house. Encountering blacked out conditions he was able to locate the victim on her bed unconscious. Captain Zidar and Firefighter Smith were able to remove the victim through he window to the safety of outside. However, once outside they encountered a swarm of bees which began stinging the firefighters and the victim. They then were able to move the victim from the backyard to the front of the house and away from the bees. Here she was transferred to an awaiting medical crew which treated and transported the female to a local ER. She regained consciousness during treatment enroute to the hospital. Upon arrival at the ER she was admitted to the ICU where she was able to make a full recovery. It is no doubt that had Captain Zidar and Firefighter Smith not quickly recognized the situation and transitioned to a VEIS the victim would have perished in the fire.


