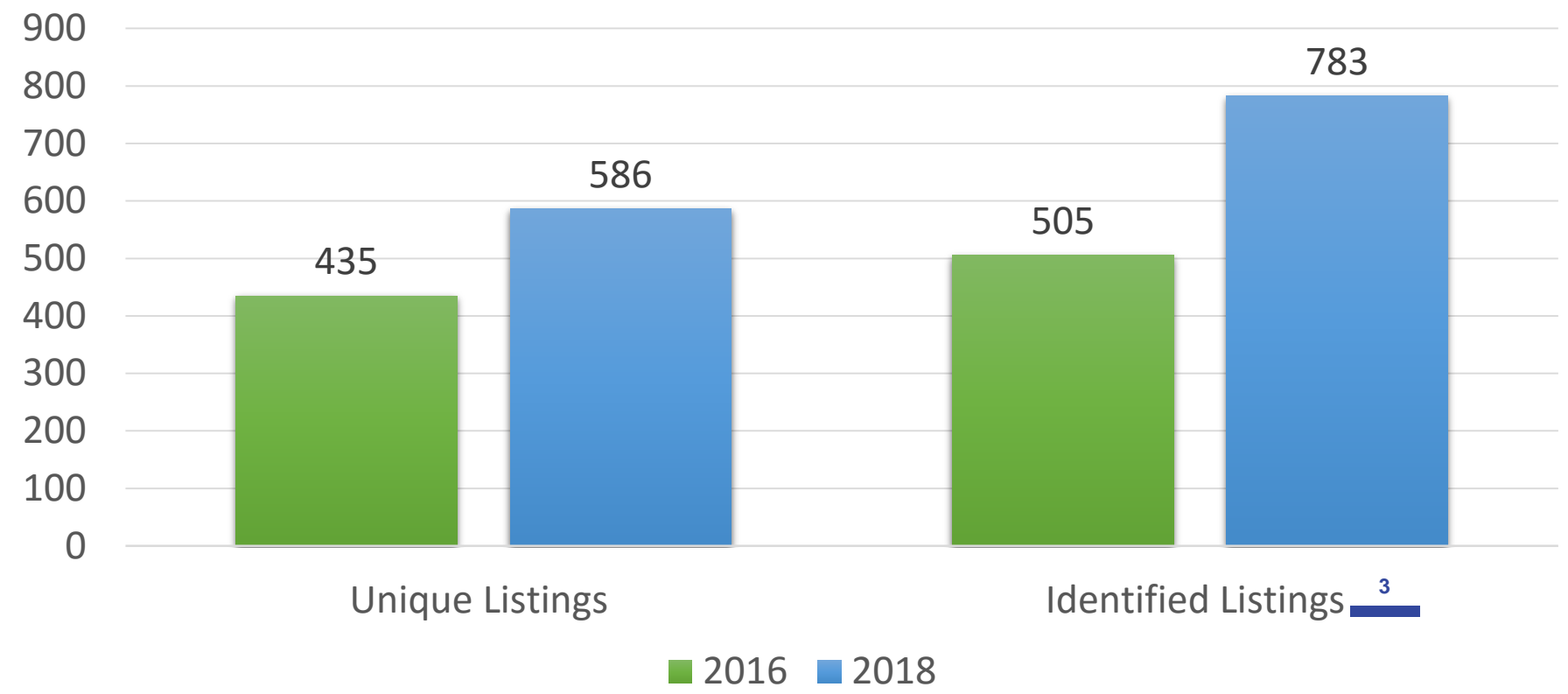


# Background

## SHORT TERM RENTALS IN DELRAY BEACH

Delray Beach 's Short Term Rentals (STRs)  
(May 2018)

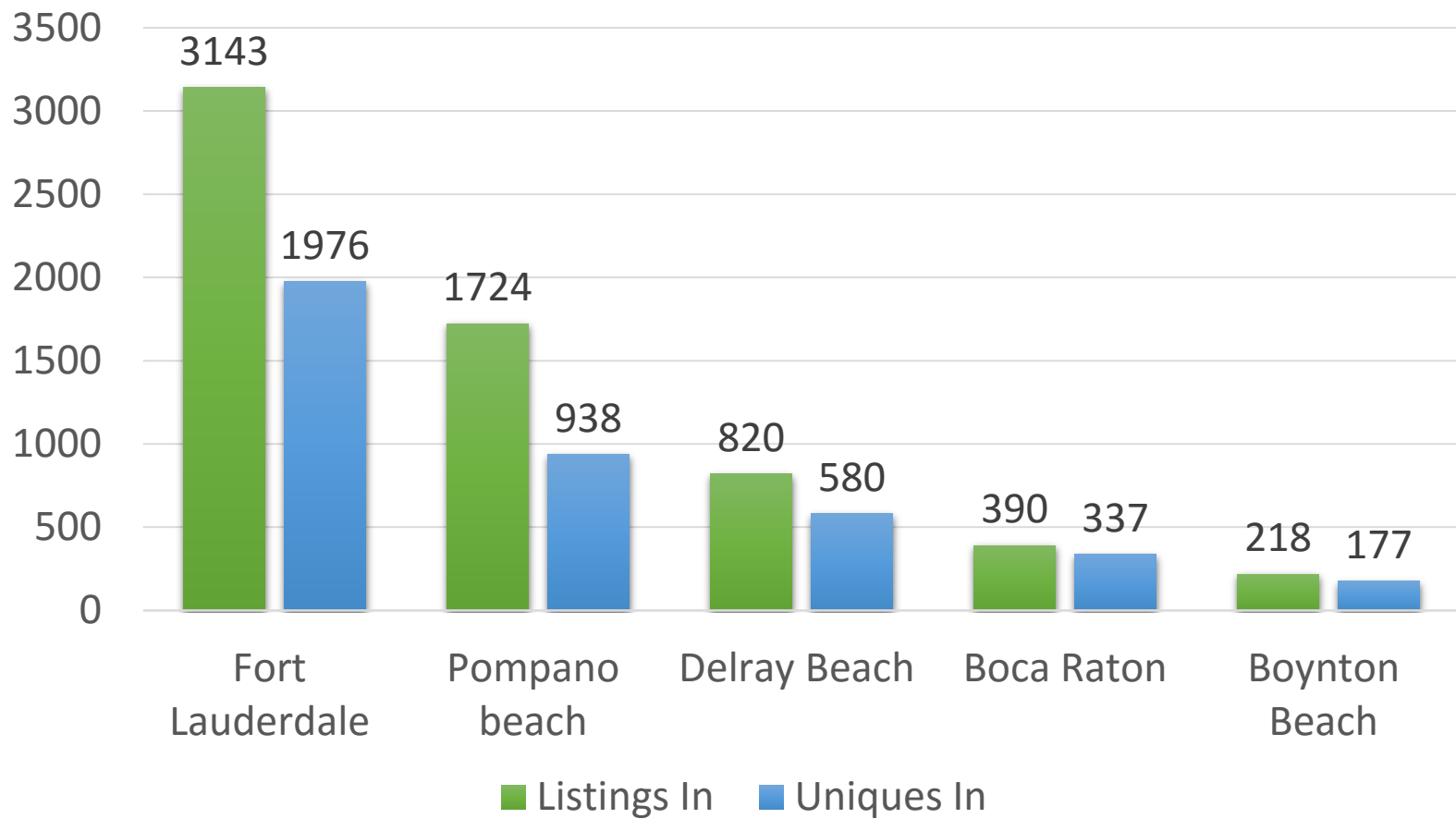
- **435** Listed in 2016
- **586** Listed in 2018
- **35%** Increase since 2016

# ISSUES

## Public available data for majority of properties

- Interior photos
- Listing description
- Location within half a mile of actual location

## Data that can be acquired through the use of sophisticated technology or labor

- Address
- Owner name
- Permit information

## Data that is impossible to obtain for majority of Municipalities

- # of nights rented per month/quarter/year
- Rental revenue per month/quarter/year

# CHALLENGES

- Complaint Driven
- Interior Photos Listed
- Address Data Hidden
- Manually Monitoring Listings



# ... SERVICES NEEDED

**Address Identification:** Monthly updates of listing information and Screen Shots of all identifiable STR's

**Hotline: 24/7:** Staffed telephone hotline for neighbors to report non-emergency STR problems



# FISCAL IMPACTS

## *Proposed Program Administration Costs*

|                       | Proposed Program Administration Costs to Delray Beach (600 Units) |
|-----------------------|---|
| Administrative        | \$49,000  |
| Mailing Notices (5)   | \$15,000  |
| Inspection Time       | \$27,000  |
| Projected Vendor Cost | \$30,000  |
| Vehicle Expenses      | \$8,180.00  |
| Total                 | \$129,000   |

## *Proposed Fee Structure*

| City         | Business Tax Fee | Inspection Fee | Estimated Units | Estimated Fees |
|--------------|------------------|----------------|-----------------|----------------|
| DELRAY BEACH | \$190.30         | \$25.00        | 600             | \$129,180      |





# RECOMMENDATIONS

## *Option 1)*

Require Vacation Rentals to register with Business Tax Office before March 2019. In addition, contract with a service provider to assist with identifying and monitoring STR's.

## *Option 2)*

- Bring back for discussion after March 2019 Legislative session.
  - **HB 773** – *Local law ordinances may not prohibit vacation rentals, regulate the duration, nor frequency.*
  - **HB 789** – *The state will regulate the registration of real property owners who lease or rent their property.*
