A RESOLUTION OF THE DELRAY BEACH COMMUNITY REDEVELOPMENT AGENCY ADOPTING AMENDMENT NUMBER 2 TO THE BUDGET FOR THE FISCAL YEAR OCTOBER 1, 2017 TO SEPTEMBER 30, 2018; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING FOR AN EFFECTIVE DATE

- All resolutions or parts of resolutions in conflict herewith are hereby 4. repealed to the extent of such conflict.
- This Resolution shall become effective immediately upon its passage and 5. adoption.
