Please justify the nomination by providing specific details (use additional sheets if necessary): On December 10, 2018, Officer Michelle Geiger responded to a DFC call regarding 9 year old girl who had a broken arm. After speaking to the family of eight, it was apparent that they were in desperate need of help. The two-month-old baby did not have a crib and some of the children did not have a bed and were sleeping on the floor. The mother and father spoke limited Spanish since they are originally from a remote tribe in Guatemala. The father works in construction and stated he is often exploited due to his immigration status and not paid. The mother stays home to care for the children, ages two months to twelve years old. The living conditions and the family's struggle impacted both Officer Geiger and the supervisor on scene. Officer Geiger left the address and immediately went and purchased an air mattress, pillows, bed sheets, blankets and covers, a crib for the baby, cases of water and a Christmas Tree. The children told Sergeant Danny Pacheco grew up fearing police. They also said they have nightmares of the day police will knock on the door and that they will be deported. Officer Geiger's actions changed the children's fear of and view of the police. She showed them kindness, compassion and a sense of protection. Officer Geiger changed the negative narrative often painted across the policing profession and positively impacted a family once fearful of police.
