THIS AMENDMENT NO. 1 to the Master Contractor/Services Agreement for Vehicle Equipment and Installation Services dated April 3, 2018, by and between City of Delray Beach, a municipal corporation of the State of Florida (hereinafter referred to as "City"), and Strobes-R-Us, Inc. WITNESSETH:

**WHEREAS**, on April 3, 2018, the City entered into an agreement with Contractor for vehicle equipment and installation services (hereinafter referred to as the "Agreement") pursuant to Resolution No. 22-18, utilizing existing contract prices, terms, and conditions provided to the City of Miami pursuant to its Solicitation No. 516388; and

**WHEREAS**, on October 23, 2018, in accordance with Solicitation No. 516388, the City of Miami exercised its second option to renew Solicitation No. 516388 through January 24, 2020; and

**WHEREAS**, the City desires to continue to procure these products and services from Contractor through January 24, 2020, utilizing existing contract prices, terms, and conditions provided to the City of Miami pursuant to Solicitation No. 516388; and

**WHEREAS**, Contractor agrees to continue to provide services to City in accordance with the terms and conditions of the Agreement.

**NOW, THEREFORE**, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Agreement is amended as follows:

1. The above recitals are true and correct and are incorporated herein.
2. This Amendment No. 1 renews the Agreement, under the same terms and conditions, for the period of January 25, 2019 through January 24, 2020.
3. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby confirmed. The Agreement and this Amendment No. 1 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.

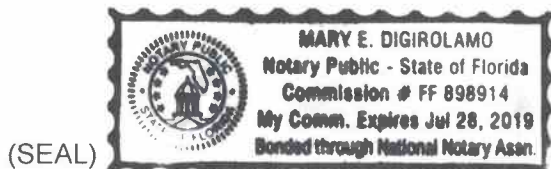
