Proposer must have personnel on staff whom are licensed Professional Mechanical, Electrical and Plumbing Engineers in the State of Florida. **Provide** proof confirming Proposer meets the criteria criterion stated above.

## **QUESTIONS AND RESPONSES:**

- Q1. The initial building layout designed by West Architecture + Design is included in the RFQ. What significance does the provided layout have on this RFQ?
- R1. The initial building layout is provided to Proposers for reference of what the City previously designed only and does not have any bearing on the selected Proposer's building layout. The similar RFQ previously awarded to West Architecture + Design encompassed the building only, whereas this RFQ encompasses the building and site.

## Q2. On page 23:

- "d. Proposer must have personnel on staff whom are licensed Professional Mechanical Electrical and Plumbing Engineers in the State of Florida. Provide proof confirming Proposer meets the criteria stated above." DOES THIS MEAN IN-HOUSE MEP OR CAN MEP SERVICES BE PROVIDED BY A SUB CONSULTANT? WHAT IS PROOF LICENSES?
- R2. In accordance with Section 4.5, subconsulting is permitted for all disciplines. Yes, a license is a form of proof to verify that the Proposer's staff is appropriately licensed. Furthermore, the minimum qualification referenced has been revised to provide additional clarity.
