SIGNIFICANT ARRESTS / INCIDENTS

- 18-18913, Grand Theft- 22 SE 1st Avenue (Federspiel Parking Garage). The victim was getting things out of her vehicle to walk to Atlantic Avenue. While taking items out of her vehicle, she sat her backpack containing MacBook computers and her iPad, on the ground while she retrieved other items from her vehicle. She walked away, forgetting to take her backpack. Shortly after she left and realized she forgot her backpack, she returned to the location and backpack was gone.
- 18-18334, Aggravated Battery- 802 NE 1st Street (Veterans Park). On December 10th, officers responded to the victim being hit in the mouth by Stephen Alves, causing the victim's left front tooth to be knocked out. Officers met with Alves, who spontaneously uttered "I didn't mean to hit him that hard". Alves was arrested and transported to the PBCJ.
- 18-19030, Aggravated Battery/Trespassing- 95 NE 1st Avenue (Old School Square Garage).
 On December 22nd, the victim stated she had been sleeping on the fifth floor of the parking garage by herself when she awoke to the sound of Jeffery Mogey and Willie Ivory walking up the stairs. The victim and Ivory got into a verbal altercation and Ivory subsequently hit her on her head with his cane. Ivory was arrested.
- 18-19075, Business Burglary- 777 E. Atlantic Avenue (A Blast from the Past). On December 24th, the business alarm activated at 0214 hours. The victim ignored the alarm, believing her cat who stays in the business tripped it. The victim later checked her surveillance camera and noticed a shattered window at her store front. Surveillance depicts a W/M throwing multiple white rocks at the store front window pane. Several panes of glass were hit and the glass window on the left side of the main door shattered. The suspect is then seen stealing a Louis Vuitton train bag, a Louis Vuitton duffel bag and a gold-plated skull umbrella (total value \$4,500). Still photos were emailed to PD personnel. Clean and Safe Officers Gordon and Caceres-Duque identified the suspect as Patrick Hullinger. Hullinger was later located at Veterans Park, wearing the same clothing, and was arrested. The stolen items were later recovered and returned to the owner.
- 18-19297, Vandalism 96 NE 2nd Avenue. On December 29th, overnight security reported that a couple had a domestic dispute near the Christmas tree. The female ripped some ornaments from the tree and destroyed them before both left northbound on NE 2nd Avenue.

PROBLEM AREAS / CITIZEN COMPLAINTS / VAGRANTS / TRANSIENTS

• Veterans Park: Negative activity appears to be picking up. Road Patrol arrested a suspect there for a burglary that had occurred at A Blast from the Past and vagrants have been congregating in the northeast portion of the park near the ICW. Towards the end of the month they also had to be ejected from the pavilion. Extra Patrols and Walk and Talks continue to be conducted regularly. Arrests: 3, Extra Patrols: 46, Walk and Talks: 56.

- Libby Wesley Park: Officers continue to monitor this park for negative activity and eject users after park hours end when needed. Extra Patrols:18, Walk and Talks: 6.
- Old School Square: Officers continue to show presence in the area. When it was noted that the homeless were sleeping in the stairwell overnight, patrols were increased.
- Vagrants: Officers reported an influx of new vagrants to the area, but when Sergeant Baer checked with Advocate Ciancio against last year's December numbers, she reported little or no increase. W/M Kevin Coy returned to town and told officers he was given free housing in West Palm Beach but wound up buying himself a hammock because he can only sleep outside. Coy frequently generates calls for service due to sleeping (and it is believed defecating) in the OSS garage stairwells and sleeping on benches around downtown as well as numerous medical calls.
- Traffic: Officers continue to educate drivers regarding the City's ordinance regarding trucks on the Avenue. Officers continue traffic enforcement due to issues with vehicles stopping on the railroad tracks by conducting traffic selectives to educate drivers and pedestrians. Officers are stopping cars that are discharging passengers in the roadway and educating pedestrians regarding Jaywalking laws.

TRAINING / SPECIAL ASSIGNMENTS

- Sergeant Quinn attended the Leadership Delray session.
- Unit officers completed vehicle in-service training (felony stops/stop sticks).
- Unit officers are tasked with making merchant contacts daily.
- Unit officers were tasked with providing security during holiday events: Santa Con, Christmas parade, New Year's Eve celebration and extra patrols at Old School Square due to crowds drawn for Christmas tree/Santa, carousel and other activities at the park.

COMMUNITY INVOLVEMENT

- Officers Jaworski and Parzyck assisted with toy deliveries for the DBPD Toy Drive.
- Officer Brotz and Sergeant Quinn trained the DBPD Explorers in traffic stops and attended a holiday dinner.
- Officers Salguero and Caceres-Duque participated in the Heroes and Helpers event at Target on December 1st.
- Officer Parzyck spent time at the Teen Center.
- Sergeant Quinn attended the DBPD east sector community meeting on December 17th.
- Officer Caceres- Duque participated with bagging toys during the DBPD's Annual Toy Drive on December 18th.
- Officer Caceres-Duque volunteered with the Beach Keepers, Inc. for a clean-up of Veterans Park and the downtown area.

BUSINESS/COMMUNITY MEETINGS/OTHER

- Sergeant Baer spoke at an east sector community meeting with members of command staff at Veteran's Park on December 17th.
- Robbery Task Force overtime detail officers, POP officers, and Traffic units were assigned to the downtown during evening hours to deter robberies during the holiday season.

Operational

110 E Atlantic Ave – The restaurant at this location (Lucida) is now open for business as of Dec. 4th, sidewalk café was approved.

Weekly garage inspections – continuing as requested by Neighborhood & Community Services.

114 NW 5th Ave dumpster enclosure – Due to vagrants occupying this dumpster enclosure, a Boss Ticket was submitted to the Building Maintenance Department to remove the gate doors. This will successfully resolve the problem with the vagrants camping out inside the enclosure. The doors were removed. The parking lot will be subject to daily monitoring.

Atlantic Ave medians – No updates

Board meetings - DDA, Commission, Pineapple Grove Arts District, SETAC, Team Delray

Complaints – Previous noise complaint received from property owner north of construction site. Code enforcement previously went to site and spoke with general contractor Steve sparks. Noise complaint was found to be previously invalid at the time. Further follow-up was done on December 17, 2018. Code enforcement once again went to construction site and spoke with contractor Steve sparks who did relay that generator on site is operational after hours. Mr. Sparks relayed thirty fan coils need to be delivered to the site, water was just turned on at the property from the city less than thirty days ago. Furthermore water needs to be treated before air can be turned on. Air quality needs to be teste before air can also be turned on. Due to all circumstances generator has to be run after hours in conjunction with chapter 99.03 of the code ordinance, which states: chapter 99.03 of the code of ordinances prohibits loud and unnecessary noises. "the provisions of subsection (a)(4) o this section shall not prohibit construction, drilling or demolition work between the hours of 7:00 a.m. and 6:00 p.m. on weekdays, and between 8:00 a.m. and 4:00 p.m. on Saturdays, nor prohibit the use of any temporary pumps or machinery which are required to be operated twenty-four(24) hours a day in conjunction with construction work. Site will be monitored daily to ensure standards are upheld per noise ordinance.

1107 W Atlantic Avenue -- has been put back into compliance after cutting and removing of overgrown vegetation, torn awnings on the storm shutters. Spoke with party owner Mr. Kevin and business partner. Refer to case's 18-120792, 18-120790.



42 SW 12th Avenue – Code Officer conducted a rental house inspection at this property and uncovered discrepancies with the flooring of the property. The flooring was in need of repair and deemed unsanitary. Property owner remained in contact with the officer to come up with a means of rectifying the issue. During a re-inspection the flooring all flooring was repaired and in sanitary condition. *Refer to photographs below*.
