Approved (6-0 Annie Adkins Roof absent) the amendment to the sign program for 411 E. Atlantic Avenue as presented.

Project Description:

The subject site measures 0.31 acres (13,503 sq. ft.) and is zoned CBD (Central Business District).

At its meeting of February 25, 2015, a Blanket Sign Program was approved by the Site Plan Review and Appearance Board. At its meeting of May 13, 2015, an Amendment to the Blanket Sign Program was approved by the Site Plan Review and Appearance Board.

The proposed amendment is off-white lettering on the proposed awning above the main entrance 10” by 19’ for a total of 15.77 SF that reads “The Wine Room Kitchen and Bar”; and a rear sign, white push through copy with a black veneer, 10” by 84” for a total of 5.81 SF that reads Speakeasy. The change to the projecting sign is from bright aluminum finish to white copy with black lettering with the edges and base to have a polished aluminum finish

The action before the Board is for the approval of an amendment to the Blanket Sign Program for 411 E. Atlantic Avenue.



Recommendation

Move approval of the Amendment to the Blanket Sign Program for (2019-077) 411 E. Atlantic Avenue to include signage for The Wine Room, based upon positive findings to LDR Section 4.6.7(F)(2)(a).

Background:

The subject site measures 0.31 acres (13,503 sq. ft.) and is zoned CBD (Central Business District).

At its meeting of August 23, 2006, a Class I Site Plan Modification was approved by the Site Plan Review and Appearance Board (SPRAB) for the removal of the existing glass/aluminum storefront to restore the arched opening (restaurant entrance) to its original building design

At its meeting of February 25, 2015, a Blanket Sign Program was approved by the Site Plan Review and Appearance Board.

At its meeting of May 13, 2015, an Amendment to the Blanket Sign Program was approved by the Site Plan Review and Appearance Board.

At its meeting of June 27, 2018, a Class I Site Plan Modification was approved by the Site Plan Review and Appearance Board for architectural elevation changes to the front (south) façade and north (rear) elevation.

At its meeting of September 26, 2018, a Class I Site Plan Modification associated with architectural elevation changes to install a new fabric awning above the entrance was tabled to a date certain.

Now before the board is the request for an amendment to the Blanket Sign Program to accommodate signage for the new restaurant, The Wine Room, on the awning over the main entrance, a rear wall sign and a change in material on the approved projecting signs.

The current program consists of the following: (1) one wall sign per tenant space internally illuminated reverse channel letters with white LEDS and are polished chrome with a maximum letter height of 15". One line of copy will be permitted, and all signs shall be placed on the same plane on the centerline of the building. The projecting signs are bright aluminum finish and are 13" x 38", illuminated with push thru copy. The signs will be installed in the center line below the wall sconces. In May of 2015, the amendment to the Blanket Sign Program allowed Café Martier to move their sign to the middle of the bay and to have a colored logo score underneath the sign.

The proposed amendment is off-white lettering on the proposed awning above the main entrance 10" by 19' for a total of 15.77 SF that reads "The Wine Room Kitchen and Bar"; and a rear sign, white push through copy with a black veneer, 10" by 84" for a total of 5.81 SF that reads Speakeasy. The change to the projecting sign is from bright aluminum finish to white copy with black lettering with the edges and base to have a polished aluminum finish.

Blanket Sign Analysis

LDR SECTION 4.6.7(F)(2)(a) Blanket Sign Program

Blanket Sign Program. A Blanket Sign Program may be required for a commercial property establishing the font, color, size and locations of signs on a multiple tenant building. A Blanket Sign Program shall be approved by the Site Plan Review and Appearance Board or the Historic Preservation Board if the project is in a historic district or historically designated site. After approval of a Blanket Sign Program, individual signs consistent therewith shall be administratively approved.

The signage proposed is consistent with the intent of the Blanket Sign criteria identified above. Pursuant to LDR 4.6.7(F)(2)(a). Any deviation from the existing program results in amending the current program which are the signs identified above. The proposed signage is consistent with the existing sign program and is in harmony with the architecture of the building. The applicant has provided photographs to show the proposed awning sign is very similar to what was provided on the original awning and restaurant.

Given the review provided above, Staff recommends approval of the amendment to the Blanket Sign Program for 411 E. Atlantic Avenue.
