#### PURCHASE AGREEMENT FOR FIREFIGHTER PROTECTIVE EQUIPMENT, BUNKER GEAR

THIS AMENDMENT NO. 1 to the Purchase Agreement for bunker gear dated April 12, 2017, by and between City of Delray Beach, a municipal corporation of the State of Florida (City), and Bennett Fire Products Company, Inc. (Supplier), a Georgia corporation authorized to do business in the State of Florida, is entered into this 18th day of 301y, 2017.

#### WITNESSETH:

**WHEREAS,** on April 12, 2017, City entered into a three-year agreement with Supplier for the purchase of bunker gear; and

**WHEREAS**, City requires additional bunker gear in excess of \$100,000 per year as listed in the Purchase Agreement; and

**WHEREAS**, Supplier agrees to provide additional bunker gear to City in accordance with the terms and conditions of the Purchase Agreement.

**NOW, THEREFORE**, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Purchase Agreement is amended as follows:

- 1. The above recitals are true and correct and are incorporated herein.
- 2. Paragraph 3 of the Purchase Agreement dated April 12, 2017 shall be amended to read as follows:

This Agreement is in full force and effect upon full execution by the City of Delray Beach for an amount not to exceed Two Hundred Thousand Dollars (\$200,000.00) per year. The term of the Agreement shall be from the 1<sup>st</sup> day of April, 2017 through the 31<sup>st</sup> day of March, 2019, unless terminated earlier by the City, with one, one-year option to renew.

3. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby confirmed. The Agreement and this Amendment No. 1 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.
