## BICYCLE ORDINANCE CHANGES CONSIDERED

Registration of bicycles with the police department will not go into effect here until Oct. 1, if an ordinance now under consideration by the city commission is enacted.

Its passage was recommended by the laws and rules committee last night with two amendments, one making it effective Oct. 1 instead of Aug. 1 and another changing the registration fee from 50 to 25 cents. Only one registration would be required unless there should be a change in ownership.

Police Chief Jack Thompson asked for the ordinance as a means of curbing bicycle thefts.

The commission postponed final action in order to give opponents of the ordinance a further chance to be heard.

Much of the meeting was taken up with listening to arguments about whether there is undue noise at Little's Inn, at Pioneer Place and Dixie. John M. Hart and Bill Bergman registered complaints to the effect that the juke organ and other loud noises keeps them awake at nights.

Police Chief Jack Thompson said no other complaints have been received by the police department and Bill Avera, proprietor, assured the commission he is running a quiet, orderly place.

Mr. Hart will then take the body on the noon Florida East Coast train to Paynesville, Ohio, where regular services will be conducted Wednesday afternoon. Burial will be in the Hickok family lot at the Evergreen cemetery, where other members of the family are buried.

The following tribute was written by a friend:

"Aunt Madge" has said 'good-bye' and embarked on that long unknown voyage from whence no traveler returns.

"Mrs. John M. Hart of 226 Pioneer Place was thus affectionately known to her many friends that had steadily accumulated during the past 15 years that West Palm Beach had been her home.

"She spent the greater part of her life in Ohio, having been born in Paynesville in 1911. Her parents, Simeon and Eunice Hickok, were of that sturdy pioneer stock from Vermont that were so influential in developing northern Ohio in the early history of that state. Mrs. Hart is the last of her immediate family, but is survived by two nephews and two nieces in the north.

"Her chief interests always centered in her home, where her talents were ever manifest to the many friends who received inspiration and encouragement at her hospitable fireside. She had a smile and kind words for all. She was an optimist in spirit and believed in walking on the sunny side if such were at all available. ## DISASTER OVERTAKES CROSS-NATION FLIERS

Salt Lake City, Oct. 8.—Major D. M. Chrissey, eastbound in the transcontinental flight, was killed near here this afternoon in attempting a forced landing. Sergeant Thomas, his observer, died en route to the hospital.

Mincola, N. Y., Oct. 8.—Forty-seven airplanes started from here today and fifteen from San Francisco in the transcontinental flight for military aviators. At sundown tonight, Lieut. Belvin W. Masnard, Baptist minister of Wakeforest, North Carolina, had landed at Chicago in the lead of the west-bound fliers.

Three fatal accidents occurred. Sergeant W. M. Nevitt died of injuries received in a fall while two eastbound contestants were killed.

### Disaster at Pensacola.

Pensacola, Fla., Oct. 8.—Machinist C. E. Seibold, of Pensacola, and Boatswains Roy McMillan, of Rochester, N. Y., and Paul Reichel, of Hammononton, California, were killed this afternoon when their flying boat fell into the bay.

### COOLER IN WEST PALM BEACH

"Just tell the people who read The Post that we consider this our 'real' home now, and that we have come back from Cleveland to remain here," said John M.
