AMENDMENT NO. 2 TO
PLUMBING MAINTENANCE AND REPAIR SERVICES

THIS AMENDMENT NO. 2 to the Plumbing Maintenance And Repair Services Agreement dated April 22, 2017 (Agreement), by and between City of Delray Beach, a municipal corporation of the State of Florida (City), and Green Team Plumbing, LLC dba Greenteam Service Corp.. (Contractor), a Florida corporation, is entered into this ____ day of ____, 20__.

WITNESSETH:

WHEREAS, on March 30, 2017, the City Commission awarded a two-year agreement to Contractor for Plumbing Maintenance and Repair Services, with the option to renew for three additional one-year periods; and

WHEREAS, the term of the Agreement expires on April 30, 2019. Contractor has continued to provide services in accordance with the terms and conditions of the Agreement; and

WHEREAS, the City desires to continue to procure these products and services from Contractor and exercise the first one-year option to renew the Agreement through April 29, 2020; and

WHEREAS, Contractor agrees to continue to provide services to City in accordance with the terms and conditions of the Agreement; and

WHEREAS, the City determines that it is in the best interest of the City to approve Amendment No. 2 to renew the Agreement through April 29, 2020.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Agreement is amended as follows:

1. The above recitals are true and correct and are incorporated herein.
2. This Amendment No. 2 extends the Agreement, under the same terms and conditions, for the period of April 30, 2019 through April 29, 2020 for an annual not-to-exceed amount of One Hundred Fifty Thousand, and 00/100 Dollars (\$150,000).
3. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby ratified and confirmed.
