JANITORIAL SERVICES CITY OF DELRAY BEACH FACILITIES AGREEMENT

THIS AMENDMENT NO. 2 to the Janitorial Services City Of Delray Beach Facilities Agreement dated March 31, 2015, by and between City of Delray Beach, a municipal corporation of the State of Florida ("City"), and United States Service Industries, Inc. ("Second Party"), organized and existing under the laws of the State of Delaware and authorized to do business in the State of Florida ("Second Party"), is entered into this ____ day of _____, 2019.

WITNESSETH:

WHEREAS, on March 31, 2015, City entered into the Janitorial Services City Of Delray Beach Facilities Agreement with Second Party for janitorial services in City buildings ("Agreement"); and

WHEREAS, the Agreement called for a two (2) year term with the option to renew for an additional two-year period; and

WHEREAS, on March 30, 2019 the final term of the Agreement will expire with no remaining options to renew; and

WHEREAS, Second Party has agreed to continue to provide services to City in accordance with the terms and conditions of the Agreement; and

WHEREAS, the City desires to extend the Agreement for ninety (90) days through June 29, 2019 to ensure continuity of services while a new Agreement is awarded; and

WHEREAS, the City desires to exercise its right to extend finding that the extension will be in the best interest of the City.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Agreement is amended as follows:

1. The above recitals are true and correct and are incorporated herein.
2. This Amendment No. 2 renews the Agreement, under the same terms and conditions, for the period of March 31, 2019 through June 29, 2019.
3. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby confirmed. The Agreement, Amendment No. 1 and this Amendment No. 2 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.
