AMENDMENT NO. 1 TO
THE GENERAL PLANNING SERVICES AGREEMENT

THIS AMENDMENT NO. 1 to the general planning services agreement dated April 17, 2018, by and between City of Delray Beach, a municipal corporation of the State of Florida (hereinafter referred to as "City"), and KCI Technologies, Inc. (hereinafter referred to as "Consultant"), a Delaware corporation authorized to do business in the State of Florida, is entered into this ____ day of ____, 20__.

WITNESSETH:

WHEREAS, on April 17, 2018, the City entered into a five-year agreement with Keith and Schnars, P.A. for general planning services (hereinafter referred to as the "Agreement"); and

WHEREAS, on February 15, 2019, the City was informed that Keith and Schnars, P.A. was acquired by Consultant on January 1, 2019; and

WHEREAS, the City desires to formally adopt the company acquisition, assigning all interests and rights under the Agreement to Consultant from Keith and Schnars, P.A.; and

WHEREAS, the Consultant agrees to continue to provide services to the City in accordance with the terms and conditions of the Agreement.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Agreement is amended as follows:

1. The above recitals are true and correct and are incorporated herein.
2. The Parties agree to amend the Agreement to reflect the company acquisition of Keith and Schnars, P.A. by Consultant. The Parties further agree that all references to Keith and Schnars, P.A. are changed respectively to Consultant.
3. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby ratified and confirmed. The Agreement and this Amendment No. 1 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.

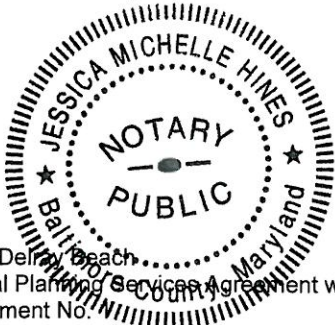
