CITY OF DELRAY BEACH AMENDMENT NO. 1 TO PURCHASE AGREEMENT FOR SOLICITATION NO. 2017-052 - JANITORIAL SUPPLIES

THIS AMENDMENT NO. 1 to the Purchase Agreement for Solicitation No. 2017-052 for janitorial supplies dated June 20, 2017, by and between City of Delray Beach, a municipal corporation of the State of Florida (hereinafter referred to as "City"), and Home Depot U.S.A., Inc. (hereinafter referred to as "Supplier"), a Delaware corporation authorized to do business in the State of Florida, is entered into this ______ day of _____, 20__.

WITNESSETH:

WHEREAS, on June 20, 2017, the City entered into a three-year agreement with Interline Brands, Inc. d/b/a Supplyworks (hereinafter referred to as the "Supplyworks") for janitorial supplies (hereinafter referred to as the "Agreement"); and

WHEREAS, on January 28, 2019, Supplyworks sent to the City a Notice of Merger, advising that Interline Brands, Inc. d/b/a Supplyworks will merge into Home Depot U.S.A., Inc. effective February 3, 2019; and

WHEREAS, City desires to formally adopt the company merger, assigning all interests and rights under the Agreement to Supplier from Supplyworks; and

WHEREAS, Supplier agrees to continue to provide services to City in accordance with the terms and conditions of the Agreement.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Agreement is amended as follows:

1. The above recitals are true and correct and are incorporated herein.

- 2. The Parties agree to amend the Agreement to reflect the company merger of Interline Brands, Inc. d/b/a Supplyworks into Home Depot U.S.A., Inc. The Parties further agree that all references to Interline Brands, Inc. d/b/a Supplyworks are changed respectively to Home Depot U.S.A., Inc.
- 3. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby confirmed. The Agreement and this Amendment No. 1 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.
