THIS AMENDMENT NO. 1 to Management Services for The Delray Beach Golf Club and Lakeview Golf Club dated May 1, 2017, by and between City of Delray Beach, a municipal corporation of the State of Florida (hereinafter referred to as "City"), and BJCE, INC. (hereinafter referred to as ("Contractor")), a Florida corporation authorized to do business in the State of Florida, is entered into this ____ day of _____, 20__.

WITNESSETH:

WHEREAS, on May 2, 2017, the City entered into a two-year agreement with BJCE, Inc. for Golf Club Management Services (hereinafter referred to as the "Agreement"); and

WHEREAS, the term of the agreement expires on April 30, 2019; and

WHEREAS, Contractor has continued to provide services in accordance with the terms and conditions of the Agreement; and

WHEREAS, the City desires to continue to procure these products and services from Contractor and exercise the first of two one-year options to renew the Agreement: and

WHEREAS, Contractor agrees to continue to provide services to City in accordance with the terms and conditions of the Agreement; and

WHEREAS, the City determines it is in the best interest of the City to approve Amendment No. 1 to renew the Agreement through April 30, 2020.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Agreement is amended as follows:

1. The above recitals are true and correct and are incorporated herein.
2. This Amendment No. 1 extends the Agreement, under the same terms and conditions, for the period of May 1, 2019, through April 30, 2020, for a not-to-exceed amount of One Hundred and Forty Thousand and/100 Dollars (\$140,000).
3. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby ratified and confirmed.
