# **RESOLUTION NO. 2019-06**

A RESOLUTION BY THE BOARD OF COMMISSIONERS OF THE DELRAY BEACH COMMUNITY REDEVELOPMENT AGENCY (CRA) APPROVING AND AUTHORIZING THE AUTHORIZED OFFICIALS TO EXECUTE THE AGREEMENT FOR PURCHASE AND SALE OF REAL PROPERTY BETWEEN THE CRA AND BH3 MANAGEMENT, LLC FOR THE REAL PROPERTY MORE PARTICULARLY DESCRIBED IN EXHIBIT "A" ATTACHED HERETO; PROVIDING FOR THE AUTHORIZATION TO THE APPROPRIATE CRA OFFICIALS TO PROCEED TO TAKE ALL ACTION NECESSARY AND TO EXECUTE ALL REQUIRED DOCUMENTS TO CONSUMMATE THE CONTEMPLATED TRANSACTION; A COPY OF THE AGREEMENT IS ATTACHED HERETO AS EXHIBIT "B"; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, the CRA Board deems it to be in the best interests of the Delray Beach CRA to approve the Agreement for Purchase and Sale of Real Property with BH3 Management, LLC; and

**WHEREAS,** Section 163.380(2), Florida Statutes (2018) provides that the CRA may sell real property at a value determined to be in the public interest for uses in accordance with the community redevelopment plan and in accordance with the CRA's property conveyance procedures; and

WHEREAS, as provided in Section 163.380(2), Florida Statutes (2018), in disposing of real property, the CRA may consider the long term benefits to be achieved from the proposed development to both the CRA and the City of Delray Beach, including, but not limited to, increasing the tax base in the West Atlantic Avenue area, the creation of jobs and commercial businesses to be located in the development area; and

**WHEREAS**, the proposed development will prevent the recurrence of slum and blight in the Community Redevelopment Area by developing underutilized and vacant property as described in Exhibit "A" located within the West Atlantic Avenue Redevelopment Area; and

WHEREAS, the CRA finds that the proposed development will result in an increase to the City's tax base, and address a community need and that these positive impacts from the proposed Development are consistent with specific goals and objectives as stated in the City's Community Redevelopment Plan and the West Atlantic Avenue Redevelopment Plan; and

WHEREAS, through the adoption of this Resolution, the Board of Commissioners of the Delray Beach Community Redevelopment Agency finds that the proposed development contemplated in the Purchase and Sale Agreement as submitted by BH3 Management, LLC is consistent with the Community Redevelopment Plan, provides for significant long term benefits to the Community Redevelopment Area, and hereby finds that the conveyance of the real property to BH3 Management, LLC is for fair value, and authorizes and approves the sale and conveyance

of the property pursuant to the terms set forth in the Purchase and Sale Agreement previously identified as Exhibit B attached hereto.

### THEREFORE. BE IT RESOLVED BY THE BOARD OF NOW. COMMISSIONERS DELRAY OF THE CITY OF BEACH COMMUNITY **REDEVELOPMENT AGENCY AS FOLLOWS:**

Section 1. The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby incorporated herein.

Section 2. The Board of Commissioners of the Delray Beach Community Redevelopment Agency hereby approves and authorizes the authorized officials to execute the Agreement for Purchase and Sale of Real Property and any and all related documents to facilitate the transaction between the CRA and BH3 Management, LLC for the real property more particularly described in Exhibit "A" attached hereto. A copy of the Agreement is attached hereto as Exhibit "B".

<u>Section 3.</u> The CRA Board of Commissioners finds that the proposed development furthers the Project Objectives contained in Section A, 1.1, entitled "West Atlantic Redevelopment Plan," of the CRA's Community Redevelopment Plan, which includes the following specific objectives with respect to proposed development in the West Atlantic Redevelopment Area:

- 1. Eliminate blighted conditions along West Atlantic Avenue and adjacent side streets.
- 2. Encourage economic growth and redevelopment.
- 3. Increase job opportunities within the West Atlantic Redevelopment Area.
- 4. Promotion of businesses which serve the neighborhood residents.

<u>Section 4.</u> The CRA Board of Commissioners find that the proposed development will provide for significant long-term benefits to the Community Redevelopment Area, including increased revenues to the City, the creation of new employment opportunities, and that the development will address and eliminate the recurrence of slum and blight within the CRA's Community Redevelopment Area.

Section 5. The CRA Board of Commissioners, pursuant to the requirements of Section 163.380(2), Florida Statutes (2018), and based upon the above-referenced plans, reports, and supporting documentation referenced herein, finds that the Agreement for Purchase and Sale between the CRA and BH3 Management, LLC which is attached hereto as Exhibit "B", (the "Agreement"), and incorporated herein by reference, provides for the conveyance of the Property described in Exhibit "A", for fair value.

Section 6. The CRA Board of Commissioners hereby approves the Purchase and Sale Agreement and directs the Delray Beach Community Redevelopment Agency's Chair, Vice-Chair, Executive Director, and General Counsel to take all necessary action consistent with this Resolution, in order to convey the Property to BH3 Management, LLC including, but not limited to the execution of the Agreement, instruments of conveyance, and the closing statement. Section 7. All resolutions inconsistent or in conflict herewith shall be and are hereby repealed insofar as there is conflict or inconsistency.

Section 8. If any section, sentence, clause, or phrase of this Resolution is held to be invalid or unconstitutional by any court of competent jurisdiction then said holding shall in no way affect the validity of the remaining portions of this Resolution.

Section 9. This resolution shall become effective upon its passage and adoption by the City of Delray Beach Community Redevelopment Agency Board of Commissioners.
