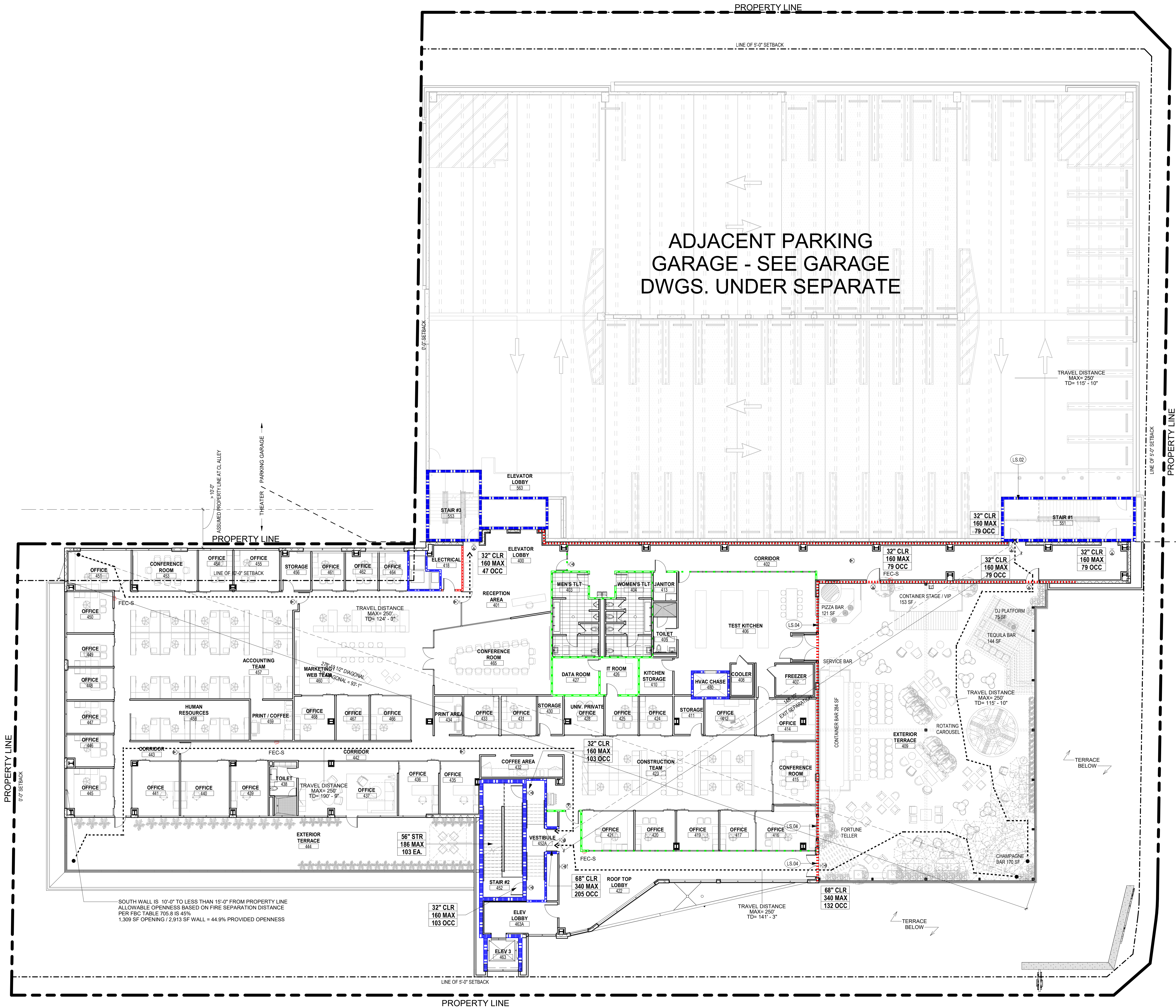




GENERAL NOTES

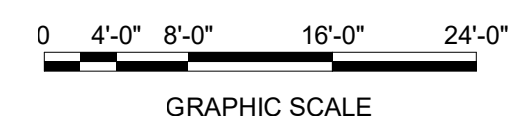
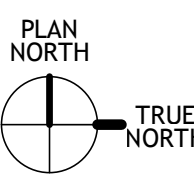
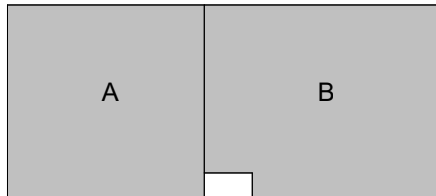
