## OPEN SPACE, PARKS, AND RECREATION

### WHAT IS THE OPEN SPACE, PARKS, AND RECREATION ELEMENT?

The Open Space, Parks, and Recreation Element is the City of Delray Beach's plan for providing a high quality system of parks, open space, recreational facilities and programs now and to meet future projected demands and recreation trends.

Open space, parks, and recreation are interconnected to other elements of the Comprehensive Plan. Beyond the provision of leisure and recreational activities, quality parks and recreation programs foster economic benefits by promoting tourism, and revitalizing communities by creating safer, more desirable neighborhoods. Community open spaces expand cultural ties through the provision of public art and the celebration of historic venues by providing a unique sense of place for the community. All of which promotes civic pride and engagement. Parks and open space support sustainability efforts through the protection and preservation of natural resources. Recreational opportunities promote healthier lifestyles and improve the mental and physical wellbeing of the residents and visitors.

Delray Beach is a diverse community whose fabric is a rich blend of cultures, ages, and both seasonal and year-round residents and visitors. While the diverse needs, interests, and experiences of Delray Beach residents enrich the City, it also provides challenges on how to best to serve the varied needs and desires of all residents. To ensure that a priority for a high quality of life remains for current and future generations, it is necessary that the parks, recreation, and open spaces system continually addresses the growing population and demographic changes, and changes in cultural trends and interests.

## GOAL OPR 1 EXCELLENT OPEN SPACES, PARKS, AND RECREATIONAL OPPORTUNITIES

**PROVIDE EXEMPLARY OPEN SPACES, PARKS, AND RECREATIONAL FACILITIES THAT ENHANCE QUALITY OF LIFE, PROVIDE RECREATIONAL OPPORTUNITIES, ENRICH INTERACTION WITH OTHERS, AND PROMOTE PHYSICAL AND MENTAL WELLBEING FOR RESIDENTS AND VISITORS OF THE CITY.**

**Performance Measures:** Success in addressing Objectives and Policies of **Goal OPR 1** shall be measured utilizing the following performance indicators:

- Implementation of and adherence to the adopted Local Level of Service Guideline criteria;
- Amount of land acquired and/or retained for parks and open space;
- Improved and increased provision of facilities and programs which meet community needs; and,
- Provision of parks and recreational facilities by private development.

### Objective OPR 1.1 Level of Service

Initiate a study to establish and adopt a Local Level of Service Guideline criteria for the calculation of the amount and types of parks, open space, and recreation facilities to serve the community.

#### Policy OPR 1.1.1

Explore criteria other than per capita measurements in the development of the Local Level of Service Standard Guideline criteria that more effectively measure the provision of park and recreation services to residents in all areas.

#### Policy OPR 1.1.2

Complete the Local Level of Service Guideline criteria within 3-5 years. [Complete by 2025]

#### Policy OPR 1.1.3

Provide and maintain a variety of parks, open spaces, and recreation facilities that serve the city's current and future population based on the adopted Local Level of Service Guideline criteria.

(Objective A-1 Carried Forward)

#### Policy OPR 1.1.4

Establish a criteria that requires a minimum 5.7% of the City's Planning Area to be dedicated to publicly-owned open space, parks, and recreational facilities; when increased, this minimum percentage will adjust accordingly.

### Objective OPR 1.2 Open Space Acquisition and Retention

Employ multiple strategies for the acquisition and retention of parkland, conservation areas and environmentally sensitive open spaces.

Expand parkland area and ensure that no parkland is diverted to other uses, except in instances of overriding public interest, in which case it shall be effectively replaced so that no net loss in acreage results.

Due to limited number of public open space, parks, and recreational facilities located west of Interstate 95, the City will not offer for sale the City's golf courses. ## GOAL OPR 2 PARK SAFETY AND ACCESS

### IMPROVE PUBLIC SAFETY AND INCREASE ACCESSIBILITY TO OPEN SPACES, RECREATIONAL FACILITIES, BEACHES, AND SHORES.

**Performance Measures:** Success in addressing Objectives and Policies of **Goal OPR 2** shall be measured utilizing the following performance indicators:

- Decrease in safety issues and concerns within City parks and facilities as a result of completed improvements;
- Improved accessibility to parks and recreational facilities as a result of completed improvements; and,
- Public access to the beach enhanced without impact to natural environment.

#### Objective OPR 2.1 Park Safety

The City will address the safety of park patrons through appropriate physical designs and infrastructure improvements.

**Policy OPR 2.1.1** Employ Crime Prevention Through Environmental Design (CPTED) principles that promote natural surveillance and open visibility at its parks and recreation facilities.

- The Police Department shall review all park designs to employ CPTED principles.
- Conduct a safety analysis and CPTED review of all existing park facilities and identify strategies to increase real and perceived safety.

#### Policy OPR 2.1.2

Evaluate the need for additional lighting in public open spaces and recreation paths, using CPTED principles.

#### Policy OPR 2.1.3

Provide for adequate fencing of public park facilities to protect patrons, while avoiding barriers to natural surveillance.

#### Policy OPR 2.1.4

Evaluate the need for, and feasibility of, security cameras and surveillance technology in public open spaces.

#### Policy OPR 2.1.5

Provide patrol of parks by the City's Police Department during operating hours.

#### Policy OPR 2.1.6

Provide permanent canopies, pavilions, or other open-air structures to be used as shelters from inclement weather within all parks.

#### Objective OPR 2.2 Park Accessibility and Connectivity

Improve multimodal connections and accessibility to parks and open space and recreation facilities to facilitate safe access for all users.

#### Policy OPR 2.2.1

Support expansions of multimodal transportation systems and networks operated by the City and County, to link residential neighborhoods with parks, open spaces and recreation facilities. Improvements within ¼ mile of parks, open spaces, and recreational area shall be prioritized.

#### Policy OPR 2.2.2

Develop a scenic recreational network plan for pedestrians and bicyclists, and make use of existing resources where possible, such as canal rights-of-way. [Complete by 2025-2040]

#### Policy OPR 2.2.3

Assess multimodal systems/networks city-wide to determine areas of missing links and inadequate infrastructure.

#### Policy OPR 2.2.4

Improve recreation opportunities west of Interstate 95 by providing bicycle and pedestrian connectivity between amenities.

## GOAL OPR 2 PARK SAFETY AND ACCESS

### Policy OPR 2.2.5

Plan interconnected greenway corridors (trails) that link native ecosystems, parks, golf courses, canals, and natural areas throughout Delray Beach.

### Objective OPR 2.3 Beach, Waterways, and Natural Areas Access

Public access to beach areas and the Intracoastal Waterway shall be retained and enhanced, while protecting the natural environment. Reworded Objective B-3 Carried Forward

### Policy OPR 2.3.1

Existing public access points and pathways to the beach shall be enhanced, particularly as a part of the Beach Nourishment Program. (Policy B-2.3 Carried Forward)

### Policy OPR 2.3.2.

Maintain the high quality of the Municipal Beach by limiting beach concessions to those under contract with the City to provide recreational amenities for beach visitors, limited to rental of chairs, umbrellas, cabanas, and boogie boards. All other concessions are prohibited. Cooking, smoking, and pets are prohibited on the beach.

### PROVIDE FOR THE PRESERVATION AND ENHANCEMENT OF OPEN SPACES, CONSERVATION AREAS, AND ENVIRONMENTALLY SENSITIVE LANDS

**Performance Measures:** Success in addressing Objectives and Policies of **Goal OPR 3** shall be measured utilizing the following performance indicators:

- Continued protection of natural areas, conservation and environmentally sensitive areas;
- Number of completed projects to enhance or create vistas and streetscapes;
- Completion of downtown open space analysis, and implementation of recommendations;
- Inclusion of sustainable and green improvements within City parks and recreational facilities; and,
- Increased tree canopy (with an emphasis on native trees).

#### Objective OPR 3.1 Conservation and Natural Areas

Protect and Preserve natural and environmentally sensitive areas.  
(Objective B-2 Carried Forward)

##### Policy OPR 3.1.1

Identify the following areas as "conservation" or "open space" on the Land Use Map: **Reworded Policy B-2.1 carried forward**

- The FIND parcels 645, and 650 along the Intracoastal;
- The Leon Weekes Environmental Preserve;
- Delray Oaks; and
- The Donnelley Tract on Palm Trail.
- The Public Beach Dunes

**Policy CSR 4.2.6**

##### Policy OPR 3.1.2

Apply the Open Space and Open Space and Recreation Zoning Districts of the Land Development Regulations to "Recreation", "Open Space" and "Conservation" designated parcels. The Open Space zones shall provide for distinct standards applicable to open space lands and to conservation lands. **Reworded Policy B-2.2**

##### Policy OPR 3.1.3

Continue to preserve, restore, protect and maintain naturally occurring habitats such as beaches, dunes, and coastal vegetation.

##### Policy OPR 3.1.4

Design open spaces and recreation facilities to minimize the impact of human activities on natural systems.

## GOAL OPR 3 OPEN SPACE PRESERVATION AND ENHANCEMENT

### Policy OPR 3.2.1

Provide and maintain view corridors for the public using open spaces within a private development or subdivision by locating common areas contiguous to the external street system.

### Policy OPR 3.2.2

Continue on-going street beautification efforts, including programs such as Adopt-A-Tree, landscaping upgrades as part of street construction projects, and an emphasis on providing sufficient funds to maintain existing landscaping at a high level. **Policy B-1.2 carried forward**

### Policy OPR 3.2.3

Require new developments provide central focal points at entries and landscape buffers along the external (arterial, collector) streets that service them. Back-lotting of individual homes along such streets should be allowed only when special landscape buffers are provided between the rear yard walls or fences and the right-of-way. **Policy B-1.3 carried forward**

**Policy CSR 4.2.4**

### Policy OPR 3.2.4

Maintain public rights-of-way that provide view corridor or vistas to water bodies and, whenever possible, provide features such as benches, landscaping, and trash receptacles to enhance the areas as pocket parks.

### Policy OPR 3.2.5

Provide consistent wall and fence treatments for all new developments when the rear of lots faces the right-of-way without any separating green space.

Determine downtown areas in need of public civic and open space, and methods to provide civic and open space at a scale that is consistent with the scale and character of downtown.

Provide a range of civic open spaces throughout the downtown through the development review process.

### Policy OPR 3.3.2

Create a strategy and the necessary partnerships to, on a temporary basis, convert vacant lots within the downtown to useable open space, which may include temporary installations.

Incorporate parklets, which are small, useable parks converted from on-street parking spaces, as a technique to provide more landscaped areas on streets with limited street trees and green spaces. [Complete by 2021]

**Policy CSR 8.4.2**

### Policy OPR 3.3.4

New developments within the downtown area shall provide and maintain publicly accessible civic open space and associated features to enrich the urban environment.

### Policy OPR 3.3.5

Evaluate development bonuses within the downtown area for dedicating a meaningful portion of a site as public open space, exceeding the minimum civic open space requirements, and designing the area as a park or plaza.

#### Objective OPR 3.4 Sustainability

Evaluate creative methods to incorporate and implement sustainable practices and green infrastructure within the City's park.

### Policy OPR 3.4.1

Identify suitable locations for urban agriculture and community gardens within parks and on appropriate public lands.

### Policy OPR 3.4.2

Support creative approaches to managing gardens, such as support by educational institutions or volunteer management by community organizations.



## GOAL OPR 3 OPEN SPACE PRESERVATION AND ENHANCEMENT

Evaluate the implementation of green infrastructure, including parks and native plants, to capture and retain storm water and encourage on-site retention.

### Policy OPR 3.4.4

Explore locations for bio-swales and native plants, including their use in pocket parks as part of a flood-control management system.

Evaluate the role of the alleyway systems and their potential as a part of bike trails, recreation and open space, and sustainable systems.

Prioritize expansion of the reclaimed water system to all parks.

### Objective OPR 3.5 Tree Canopy

Preserve and enhance the tree canopy to mitigate the heat island effect and provide beautification throughout Delray Beach.

Conduct a formal study of the existing tree canopy (with a native canopy component) and adopt strategies to protect and enhance the canopy. The study shall evaluate canopy coverage in both public rights-of way and on private properties to determine areas with inequitable coverage. ## GOAL OPR 4 PUBLIC PRIVATE PARTNERSHIPS

### PROMOTE PUBLIC-PRIVATE PARTNERSHIPS TO ACQUIRE, MAINTAIN, AND ENHANCE PARKS, OPEN SPACES AND RECREATIONAL FACILITIES.

**Performance Measures:** Success in addressing the Objectives and Policies of **Goal OPR 4** shall be measured utilizing the following performance indicators:

- Improved and/or increased parks and recreational experiences offered;
- Number of partnerships or agreements with the private sector relative to programming and maintenance of open spaces; and,
- Implementation of new outreach programs to increase public participation in programming of parks, open spaces, and recreational facilities.

#### Objective OPR 4.1 Public Partnerships

Coordinate with other public entities to expand the park and recreation experiences of all residents.
