THIS AMENDMENT NO. 1 to the City-Wide Project Management Services Agreement dated June 6, 2017, by and between City of Delray Beach, a municipal corporation of the State of Florida (hereinafter referred to as "City"), and CDM Smith Inc. (hereinafter referred to as "Second Party"), a Massachusetts corporation authorized to do business in the State of Florida, is entered into this 15th day of May, 2018.

WITNESSETH:

WHEREAS, on June 6, 2017, the City entered into a one-year agreement with Second Party for project management services (hereinafter referred to as the "Agreement"); and

WHEREAS, the City determines that it is in its best interest to renew the Agreement through June 5, 2019, utilizing its first of four one-year renewal options, in accordance with the terms and conditions of the Agreement; and

WHEREAS, Second Party agrees to continue to provide project management services to City in accordance with the terms and conditions of the Agreement.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Agreement is amended as follows:

1. The above recitals are true and correct and are incorporated herein.
2. This Amendment No. 1 renews the Agreement, under the same terms and conditions, for the period of June 6, 2018 through June 5, 2019.
3. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby confirmed. The Agreement and this Amendment No. 1 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.

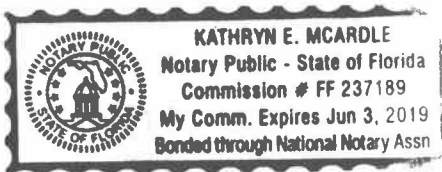
