THIS AMENDMENT NO. 1 to the City-Wide Project Management Services Agreement dated June 6, 2017, by and between City of Delray Beach, a municipal corporation of the State of Florida (hereinafter referred to as "City"), and CDM Smith Inc. - 1. The above recitals are true and correct and are incorporated herein.
- 2. This Amendment No. 1 renews the Agreement, under the same terms and conditions, for the period of June 6, 2018 through June 5, 2019.
- 3. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby confirmed. The Agreement and this Amendment No. 1 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.
