CREATION OF A HEALTHY COMMUNITY ELEMENT

The Healthy Community Element is new to the Comprehensive Plan. The Healthy Community Element demonstrates that improving and maintaining overall health for the residents of the City is an important factor in providing a high quality of life. The American Planning Association defines "healthy communities" as places where all individuals have access to healthy built, social, economic, and natural environments that give them the opportunity to live their fullest health potential regardless of their race, ethnicity, gender, income, age, abilities, or other socially defined circumstance.

The inclusion of this element provides a path for enhancing the health and well-being of Delray Beach's residents through the implementation of the goals, objectives and policies recommended within the Element.

WHAT CHANGED?

CREATION OF A HISTORIC PRESERVATION ELEMENT

Emphasizes the City's historic preservation programs and efforts by creating an Element supporting historic preservation.

PROHIBITION OF ALLEY ABANDONMENTS

Currently, a policy only specifies that alleys within the Old School Square Historic District shall not be abandoned; proposed Policy specifies prohibition of alley abandonments in historic districts.

WHAT STAYED THE SAME?

Existing Objective and Policies supporting historic preservation by surveying resources, whether already designated or not, and maintaining regulations in the LDRs that support historic preservation.

These projects are also identified throughout the Elements of the Comprehensive Plan. The CIP is updated annually using prioritization standards in the Element, following an annual infrastructure hearing. These practices are maintained in the updated version.

TECHNOLOGY, SUSTAINABILITY, AND RESILIENCY

The Element is updated to include goal areas for Technology, Sustainability, and Resiliency that further the City's overall vision in these areas.

Existing Goals, Objectives, and Policies related to the prioritization of project funding, maintenance and upgrading of public facilities, quality of life, and economic development were preserved and reorganized.

COASTAL MANAGEMENT ELEMENT - OVERVIEW

WHAT CHANGED?

The Coastal Management Element sets forth the community's principles and strategies for the use and protection of the City's coastal resources. Coastal management is a multifaceted effort. Proper management ensures both the protection of life and property from natural disasters, as well as the conservation of natural resources. It strives at once to maintain and enhance the quality of life of citizens who value the area as a recreational asset, to protect wildlife and natural ecosystems, to maximize economic benefits generated from tourism, and to safeguard human life and public investment from natural disasters. Coastal Management requires a careful balance between the natural and built environments.

Revisions to the Element include an updated definition of the Coastal High Hazard Zone per current Florida Statutes; the inclusion of the updated FEMA Flood Zone areas, and the projected impacts from potential sea level rise. The City's award-winning beach nourishment program is chronicled and planned for into the future to provide for the protection of life, property, and coastal zone resources. Natural disaster planning components are also updated to reflect the City's current strategies.

WHAT STAYED THE SAME?

This element maintains previous goals related to the preservation, conservation, and enhancement of natural resources; balancing development and preservation efforts; maintaining the character of the coastal area; and disaster preparedness.

WHAT CHANGED?

The previous Conservation Element was expanded to include sustainability and resiliency issues, and renamed as the "Conservation, Sustainability, and Resiliency Element". The purpose of the Conservation Sustainability and Resiliency Element is to set forth the City's environmental stewardship principles and policies. The expanded element adds the concepts of sustainability and resiliency to include planning concepts addressing energy use, greenhouse gas emissions, and climate change, as well as preparation for natural disasters (previously addressed in the Coastal Management Element) and planning for the impacts of sea level rise.

WHAT STAYED THE SAME?

The element continues to include policies on the preservation and protection of endangered species, natural habitats, and natural areas, and protection of water quality. The previous Goal "Strive to become a More Sustainable City" has been expanded to a more detailed, actionable set of Goals, Objectives and Policies.

CHANGE FROM PUBLIC SCHOOLS FACILITIES TO EDUCATION

The previous Education Element primarily focused on public school facilities, while the updated Education Element has a broader focus on community education aspirations. It incorporates and updates the former Public School Facilities Element, as applicable, while demonstrating the importance of education to the City of Delray Beach through an emphasis on community education and programs that serve those from 0-5 years to lifelong learners. The Education Element provides an overview of all Delray Beach public school facilities and their programming, and the programs and initiatives of the City's Education Board designed to address issues identified in the community (such as the Campaign for Grade Level Reading and Delray Reads Day).

WHAT STAYED THE SAME?

The former Public School Facilities Element primarily focused on public school facilities, which has been incorporated into Goal 5, and includes the adopted Interlocal Agreement with the School District of Palm Beach County.

WHAT CHANGED?

NEW TITLE

The Neighborhoods, Districts, and Corridors Element, formerly the “Future Land Use Element”, establishes the City’s Goals, Objectives, and Policies regarding the City’s land uses to maintain and improve the quality of life for existing and future residents, visitors, and workers. The updated element changes the terminology from “future land use”, which implies a potential change from existing, to “Neighborhoods, Districts, and Corridors” to reflect the established land use pattern of the city.

CHANGES THE NAMES OF THE FOLLOWING LAND USE DESIGNATIONS:

1. “Other Mixed Use” to “Historic Mixed Use”; Old School Square Historic District is the only area where this land use designation is applied and the new name better references its purpose.
2. “Open Space - Conservation” to “Conservation”; changing the name clearly distinguishes conservation land from parks and other types of open space and reinforces the intent of long term protection the land.
3. “Recreation & Open Space” to “Open Space”; open space includes both passive and active use within this designation and the “distinction” between passive/active is regulated by the LDRs.

FLOOR AREA RATIO

1. Reduces the Floor Area Ratio (measure of intensity) in the Open Space land use designation from 0.5 to 0.1. Research of the designations indicates that no property development approaches 0.1 FAR. This change would ensure open space remains “open.”
2. Consolidates the Floor Area Ratio (FAR) in the Congress Mixed Use (CMU) land use designation to 3.0 for non-residential, residential, or mixed use. Currently, the CMU has two separate FARs for non-residential and mixed use (1.0) and residential (2.0). CMU is currently implemented by the Mixed Residential, Office, and Commercial (MROC) zoning district. MROC currently allows the highest building height and density in the City, yet affords less development potential than the downtown area or the general commercial areas. Attracting development from those areas to Congress Avenue improves the potential for transit-oriented development around the existing Tri-Rail Station, locates development on a corridor that has more capacity based on 2040 roadway trip analyses, and advances the community’s vision for Congress Avenue.

WHAT STAYED THE SAME?

The proposed Element continues the direction of the City’s plan since inception with minor “adjustments”. The updated plan is drafted in a user-friendly format and simpler language. The revised policies formalize the City’s strong history of effective planning practices, such as using Neighborhood and Redevelopment Plans created with a high degree of resident and stakeholder participation to guide changes.

LAND USE MAP DESIGNATIONS

No map amendments are proposed to the Future Land Use Map, except land use designation names. Map amendments are best made through focused projects/initiatives and not as a part of a “general” update of the plan.

TABLE NDC – 1: DENSITY, INTENSITY, AND IMPLEMENTING ZONING DISTRICTS.

A clear distinction between the “standard” density in land use designations and the potential density available only through specific City incentive programs, adopted overlays, etc. is

presented in an easy to understand chart, which is specifically referenced in the GOPs. The current plan references the potential densities in narrative form as a part of the land use descriptions that are adopted by reference. The implementing zoning districts are referenced, and preferred and compatible zoning districts are identified.
