

RESOLUTION NO. 124-19

A RESOLUTION OF THE CITY OF DELRAY BEACH, FLORIDA APPROVING THE UTILIZATION OF CONTRACT NO. FL-SEA-GC02-041019 BETWEEN SOURCEWELL, FORMERLY KNOWN AS NATIONAL JOINT POWERS ALLIANCE, A NATIONAL PURCHASING COOPERATIVE, AND SHIFF CONSTRUCTION AND DEVELOPMENT, INC. (SHIFF), FOR CONSTRUCTION AND INSTALLATION SERVICES FOR THE CITY'S PUBLIC WORKS DEPARTMENT; AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS TO SHIFF; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach ("City") is authorized to enter into agreements to provide services, programming and products in accordance with its Charter; and

WHEREAS, the City requires minor construction and electrical installation services in order preserve City assets; and

WHEREAS, the City desires to utilize the pricing from Sourcewell Contract No. FL-SEA-GC02-041019 to acquire said services; and

WHEREAS, the City desires issue Purchase Orders to Shiff Construction and Development, Inc., to obtain the necessary installation services; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

Section 1. The foregoing recitals are hereby affirmed and ratified.

Section 2. The City Commission of the City of Delray Beach has reviewed and hereby approves the utilization of Sourcewell Contract No. FL-SEA-GC02-041019 with Shiff Construction and Development, Inc. to secure pricing for necessary services for the Public Works Department.

Section 3. The City Commission of the City of Delray Beach authorizes the City Manager to issue Purchase Orders to Shiff Construction and Development, Inc.

Section 4. This Resolution shall become effective immediately upon adoption.
