CITY OF DELRAY BEACH AMENDMENT NO. 1 TO VEHICLE TOWING AND STORAGE SERVICES

THIS AMENDMENT NO. 1 to Vehicle Towing and Storage Services dated December 8, 2016, by and between City of Delray Beach, a municipal corporation of the State of Florida (hereinafter referred to as "City"), and Westway Towing, Inc. (hereinafter referred to as "Second Party", a Florida corporation authorized to do business in the State of Florida, is entered into this _____ day of ______, 20___.

WITNESSETH:

WHEREAS, on December 8, 2016 the City entered into a 3-year agreement with Second Party for vehicle towing services (hereinafter referred to as the "Agreement"); and

WHEREAS, the term of the Agreement commenced on December 11, 2016 and expires on September 30, 2019. Contractor has continued to provide services in accordance with the terms and conditions of the Agreement; and

WHEREAS, the City desires to continue to procure these service from Second Party and exercises the first one-year option to renew the Agreement through September 30, 2020; and

WHEREAS, Second Party agrees to continue to provide services to City in accordance with the terms and conditions of the Agreement.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Agreement is amended as follows:

- 1. The above recitals are true and correct and are incorporated herein.
- 2. This Amendment No. 1 extends the Agreement, under the same terms and conditions, for the period of October 1, 2019 through September 30, 2020.
- 3. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby confirmed. The Agreement and this Amendment No. 1 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.
