A RESOLUTION OF THE DELRAY BEACH COMMUNITY REDEVELOPMENT AGENCY ADOPTING THE CITY OF DELRAY BEACH'S PURCHASING POLICIES AND PROCEDURES MANUAL AS REQUIRED BY SECTION 163.370(5), FLORIDA STATUTES; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Florida Legislature and the Governor of the State of Florida approved and adopted Chapter 2019-163, Laws of Florida during the 2019 legislative session, which contained a revision to Section 163.370, Fla.Stat., to require a Community Redevelopment Agency ("CRA") to procure all commodities and services under the same purchasing processes and requirements that apply to the municipality that created the CRA; and

WHEREAS, pursuant to the requirements of Section 163.370(5), Fla.Stat., the Board of Commissioners of the Delray Beach Community Redevelopment Agency ("Board"), desires to insure compliance with the recently adopted statutory requirement, and adopt the City of Delray Beach's Purchasing Policies and Procedures Manual as the purchasing policies and procedures for the Delray Beach Community Redevelopment Agency as of October 1, 2019; and

WHEREAS, the Board determined that the adoption of the City of Delray Beach's Purchasing Policies and Procedures Manual is in the public's interest and it is necessary to implement its goals and objectives.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE DELRAY BEACH COMMUNITY REDEVELOPMENT AGENCY THAT:

- 1. Each "WHEREAS" clause set forth above is true and correct and herein incorporated by this reference.
- 2. Pursuant to Section 163.370(5), Florida Statutes, the City of Delray Beach's Purchasing Policies and Procedures Manual, in effect as of October 1, 2019, is hereby adopted as the Purchasing Policies and Procedures Manual for the Delray Beach Community Redevelopment Agency. Any amendments to the City of Delray Beach's Purchasing Policies and Procedures Manual shall be effective with respect to the Delray Beach Community Redevelopment Agency without any further action by the Board of Commissioners of the Delray Beach Community Redevelopment Agency.
- 3. Any reference to the "City of Delray Beach" or "City" as contained in the Purchasing Policies and Procedures Manual shall be interpreted to refer to the Delray Beach Community Redevelopment Agency. Any reference to the City Manager, Purchasing Director, or Requesting Director as contained in the Purchasing Policies and Procedures Manual shall be interpreted to refer to the Delray Beach Community Redevelopment Agency's Executive Director, or his/her designee.
- 4. If any clause, section, or other part of this Resolution shall be held by any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part shall be considered as eliminated and shall in no way affect the validity of the remaining portions of this Resolution.
- 5. All resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.
 - 6. This Resolution shall become effective as of October 1, 2019.
