THIRD AMENDMENT TO THE INTERLOCAL AGREEMENT BETWEEN THE CITY OF DELRAY BEACH AND THE DELRAY BEACH COMMUNITY REDEVELOPMENT AGENCY FOR FUNDING OF TRANSPORTATION SERVICES

THIS THIRD AMENDMENT TO THE INTERLOCAL AGREEMENT FOR FUNDING OF TRANSPORTATION SERVICES ("THIRD AMENDMENT") is made this day of _______, 2019, by and between the CITY OF DELRAY BEACH, a Florida municipal corporation, (hereinafter referred to as "CITY"), and the DELRAY BEACH COMMUNITY REDEVELOPMENT AGENCY, a public body corporate and politic, duly created and operated pursuant to Chapter 163, Florida Statutes (hereinafter referred to as the "CRA").

WITNESSETH:

WHEREAS, the CITY and the CRA entered into an Interlocal Agreement for the Funding of Transportation Services within the Community Redevelopment Area ("Trolley Services"), on November 6, 2018 (the "Original Agreement"); and

WHEREAS, on January 15, 2019, the CITY and the CRA approved the First Amendment to the Original Agreement ("First Amendment") to provide for the extension of the Original Agreement up to, and including April 30, 2019, and provided for additional funding to be provided by the CRA; and

WHEREAS, the CRA and the CITY entered into a Second Amendment to the Original Agreement dated April 16, 2019 ("Second Amendment") to provide for the extension of the Original Agreement up to, and including June 30, 2019; and

WHEREAS, the CRA and the CITY desire to enter this Third Amendment to extend the term of the Original Agreement, as amended, and provide for payment from the CRA to the CITY for expenses incurred for the Trolley Services from July 1, 2019 to July 14, 2019; and

WHEREAS, this Amendment is consistent with the **CRA's** Redevelopment Plan, and serves both a municipal and public purpose.

NOW, THEREFORE, in consideration of the mutual covenants and promises herein contained, the parties hereby agree as follows:

- 1. The recitations set forth above are hereby incorporated herein.
- 2. The **CRA** and the **CITY** agree to extend the term of the Original Agreement, as amended, to provide for payment from the **CRA** to the **CITY** of incurred expenses for Trolley Services from July 1, 2019 through July 14, 2019.

3. All other terms and conditions of the Original Agreement, the First Amendment, and Second Amendment not in conflict with this Third Amendment shall remain in full force and effect.
