## CITY OF DELRAY BEACH AMENDMENT NO. 3 TO PLUMBING MAINTENANCE AND REPAIR SERVICES

THIS AMENDMENT NO. 3 to the Plumbing Maintenance And Repair Services Agreement dated April 22, 2017 (Agreement), by and between City of Delray Beach, a municipal corporation of the State of Florida (City), and Green Team Plumbing, LLC dba GreenTeam Service Corp. ## WITNESSETH:

WHEREAS, on March 30, 2017, the City Commission awarded a two-year agreement to Contractor for Plumbing Maintenance and Repair Services, with the option to renew for three additional one-year periods; and

**WHEREAS**, on March 12, 2019, the City Commission exercised the first renewal and extended the terms of the Agreement to April 29, 2020, with an annual not-to-exceed amount of One Hundred Fifty Thousand and 00/100 Dollars (\$150,000); and

**WHEREAS**, the City desires to continue to procure these products and services from Contractor but increase the annual not-to-exceed budget for these services; and

**WHEREAS**, Contractor agrees to continue to provide services to City in accordance with the terms and conditions of the Agreement; and

**NOW**, **THEREFORE**, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Agreement is amended as follows:

- 1. The above recitals are true and correct and are incorporated herein.
- 2. This Amendment No. 3 increases the annual not-to-exceed amount of the Agreement to Two Hundred Fifty Thousand, and 00/100 Dollars (\$250,000).
- 3. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby ratified and confirmed.
