AMENDMENT NO. 1 TO AGREEMENT FOR PROFESSIONAL

THIS AMENDMENT NO. 1 to the Engineering Services for Marine Way Seawall and Dock Consulting Services Agreement dated October 3, 2017, by and between City of Delray Beach, a municipal corporation of the State of Florida (City), and Wantman Group, Inc. (Consultant), a Florida corporation, is entered into this ____ day of ____, 2019.

WITNESSETH:

WHEREAS, on October 3, 2017, the City entered into a three (3) year agreement with Consultant for engineering services for marine way seawall and dock consulting services (Agreement); and

WHEREAS, the City desires to amend Article 2. Scope of Services of the Agreement to incorporate Phases 2 and 3 for Design Services and Bidding Assistance of the project attached hereto and incorporated herein as Composite Exhibit "A"; and

WHEREAS, the City desire to amend Article 3. Compensation of the Agreement to increase the total not to exceed amount for professional design services related to the incorporation of Phases 2 and 3 for Design Services and Bidding Assistance, attached hereto and incorporated herein as Composite Exhibit "A"; and

WHEREAS, Consultant agrees to continue to provide services to City in accordance with the terms and conditions of the Agreement.

NOW, THEREFORE, the parties agree the Agreement is amended:

1. The above recitals are true and correct and are incorporated herein.
2. ARTICLE 2. SCOPE OF SERVICES is amended to add: The Consultant shall provide additional professional services to the City as more particularly described in Composite Exhibit "A" of Amendment No. 1 to the Agreement, which is specifically incorporated herein.
3. ARTICLE 3. COMPENSATION is amended to add: The City shall pay the Consultant an amount not to exceed One Million One Hundred Three Thousand Six Hundred and Twenty-Two Dollars (\$1,103,622) for performing professional services as detailed in and based upon the budget summary shown in Composite Exhibit "A" of Amendment No. 1 to the Agreement, which is specifically incorporated herein.
4. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby confirmed. The Agreement and this Amendment No. 1 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.

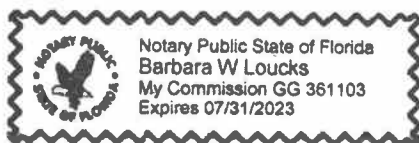
