Contract Number: FSA18-VEL26.0

Contract Name: Police Rated, Administrative, Utility Vehicles, Trucks and Vans

Renewal Period: October 1, 2019 – September 30, 2020

The Florida Sheriffs Association (FSA) is renewing select specifications in Contract FSA18-VEL.26.0, Police Rated, Administrative, Utility Vehicles, Trucks and Vans, per Section 3.04 of the Terms and Conditions. FSA has determined that it is in the best interest of the Association and eligible purchasers to renew the contract for the identified specifications below. Section 3.04 allows the contract renewal without price adjustments.

The Terms and Conditions remain in effect for the extended period for these products. Any option pricing, to include non-scheduled options, shall not exceed MSRP, per Section 2.13 and 3.17 of the Terms and Conditions.

If an awarded vendor does not appear in this list of price-protected General Motor vehicles, it is because the vendor elected not to participate in the contract renewal. Therefore, awards granted to vendors that chose not to participate in the renewal will terminate September 30, 2019.

The awarded vendors agree that the following General Motors vehicles will be price protected for the 2020 model year at 2019 contract prices. Any 2019 models in inventory may also be purchased under this renewal. General Motors anticipates a short 2020 production period for the Police and SSV Tahoes, Suburbans and Yukons. Therefore, the price and the published options are extended for the period of October 1, 2019 through September 30, 2020 for the following vehicles:
