THIS AMENDMENT NO. 1 to Comprehensive Parking Management Services dated May 16, 2017, by and between City of Delray Beach, a municipal corporation of the State of Florida (hereinafter referred to as "City"), and Lanier Parking Meter Services, LLC d/b/a Lanier Parking Solutions (hereinafter referred to as "Contractor" a Georgia corporation authorized to do business in the State of Florida, is entered into this ____ day of _____, 20__.

WITNESSETH:

WHEREAS, on May 16, 2017 the City entered into a three (3) year agreement with Contractor for comprehensive parking management services (hereinafter referred to as the "Agreement"); and

WHEREAS, upon the renewal term the City desires to increase the contract value; and

WHEREAS, City desires to renew the Agreement through September 30, 2021; and

WHEREAS, Contractor agrees to continue to provide services to City in accordance with the terms and conditions of the Agreement.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Agreement is amended as follows:

1. The above recitals are true and correct and are incorporated herein.
2. This Amendment No. 1 extends the Agreement, under the same terms and conditions, for the period of October 1, 2020 through September 30, 2021 for a not-to-exceed amount of Eight Hundred Ninety-Six Thousand and 00/100 Dollars (\$896,000).
3. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby confirmed. The Agreement and this Amendment No. 1 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.
