Renovations

The 2400 sq. ft. duplex located at 121 SW 10^{th} Avenue was built in 1992 and purchased by the CRA on January 15, 2019. It has a family living in the rear unit (B), with unit (A), vacant.

An Invitation to Bid (ITB) was issued on April 22, 2019 to renovate the property.

Hatcher Construction and Development, Inc. was awarded the contract and was given the Notice to Proceed on September 13, 2019.

The total completion date for the duplex renovation was originally December 13, 2019. Due to permitting issues and the holidays, the project was completed January 16, 2020.





Pressure Cleaning







Arts Warehouse

125 SW 5th Avenue - Habitat For Humanity

This property was one of five properties that was conveyed to Habitat for Humanity through a Purchase and Sale Agreement with the CRA executed on May 8, 2018, for the purpose of developing affordable single family homes. The construction of the home at 125 SW 5th Avenue was completed and the property was sold to the Brivaus/Demesmin family. This property was a Women Build project and a signature event took place on this site May 9, 10, and 11, 2019 honoring the generous support of 196 Women builders, with a combined 740 volunteer hours, contributed to the 1,340 total hours that were dedicated to the completion of the home. Women Build is an annual event that brings together women leaders of South Palm Beach County to transform our community and change the lives of those they help.




110 SW 12th AVE.
