Site Development Assistance Funding Program

APEX Insurance & Investment Group, LLC (702 NE 3rd Avenue, CRA Sub-Area #6, within the Del-Ida Historic District)

The owner of APEX Insurance & Investment Group, LLC, a local insurance firm, submitted an application for funding in November 2019 and is now on the CRA board meeting agenda for review and approval (2/25/2020 board meeting). A copy of the Agenda Item Summary with full project scope is available. Funding is being recommended in the amount of \$29,406.60.

As of 2/12/2020, a balance of \$19,471.00 is remaining (\$16,539.31 is withheld and can be disbursed following project completion). The work is progressing, with a rough inspection anticipated during the week of 2/10/2020, hood work to begin two weeks from then.
