CITY OF DELRAY BEACH AMENDMENT NO. 1 TO PROPERTY & CASUALTY INSURANCE BROKER SERVICES

THIS AMENDMENT NO. 1 to Property & Casualty Insurance Broker Services, by and between City of Delray Beach, a municipal corporation of the State of Florida (hereinafter referred to as "City"), and Relation Insurance Services Of Florida, Inc.(hereinafter referred to as "Second Party"), a Florida corporation authorized to do business in the State of Florida, is entered into this ^{29th} day of January, 20²⁰.

WITNESSETH:

WHEREAS, on September 20, 2016, the City entered into an agreement with Employers Mutual, Inc. dba Ascension Benefits & Insurance Solutions of Florida for Property & Casualty Insurance Broker Services (hereinafter referred to as the "Agreement"); and

WHEREAS, the City formally recognizes that Employers Mutual, Inc. dba Ascension Benefits & Insurance Solutions of Florida changed its name to Relation Insurance Services of Florida, Inc.; and

WHEREAS, the Agreement term ran from September 20, 2016, through March 31, 2020, with two, one-year options to renew; and

WHEREAS, the City desires to exercise the first one-year option to renew the Agreement, extending the terms of the Agreement through March 31, 2021; and

WHEREAS, Second Party agrees to continue to provide services to City in accordance with the terms and conditions of the Agreement.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Agreement is amended as follows:

- 1. The above recitals are true and correct and are incorporated herein.
- 2. This Amendment No. 1 renews the Agreement, under the same terms and conditions, for the period of April 1, 2020, through March 31, 2021.
- 3. That Employers Mutual, Inc. dba Ascension Benefits & Insurance Solutions of Florida changed its name to Relation Insurance Services of Florida, Inc., and both parties shall continue to honor this Agreement.
- 4. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby confirmed. The Agreement and this Amendment No. 1 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.
