THIS AMENDMENT NO. 1 to Architectural Compliance Review Services dated June 19, 2017, by and between City of Delray Beach, a municipal corporation of the State of Florida (hereinafter referred to as "City"), and Alexis Knight Architect, Inc. (hereinafter referred to as "Consultant", a Florida corporation authorized to do business in the State of Florida, is entered into this ____ day of ____, 20__.

WITNESSETH:

WHEREAS, the City entered into a three-year agreement with Alexis Knight Architect, Inc. for Architectural Compliance Review (hereinafter referred to as the "Agreement"); and

WHEREAS, the Agreement included a two-year renewal option; and

WHEREAS, Consultant agrees to continue to provide services to City in accordance with the terms and conditions of the Agreement.

WHEREAS, the City desires to continue to procure these services from Consultant and exercise the final, renewal option extending the Agreement for additional two-year period through June 18, 2022; and

NOW, THEREFORE, for and in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which is acknowledged, the parties agree that the Agreement is amended as follows:

- 1. The above recitals are true and correct and are incorporated herein.
- 2. This Amendment No. 1 extends the Agreement, under the same terms and conditions, for the period of June 19, 2020 through June 18, 2022.
- 3. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby confirmed. The Agreement and this Amendment No. 1 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.
