THIS AMENDMENT NO. 2 to the Agreement for professional services dated February 13, 2020, by and between City of Delray Beach, a municipal corporation of the State of Florida (herein referred to as "City"), and TP Southern Charm Limited LLC, a Pennsylvania Limited Liability Corporation (herein referred to as "Contractor"), is entered into this _____ day of May, 2020.

WITNESSETH:

WHEREAS, on February 13, 2020, the City entered into an Agreement with Contractor for professional services (herein referred to as "Agreement"); and

WHEREAS, on February 26, 2020, the City approved Amendment No. 1 to the Agreement to revise Exhibit "A" to the Agreement; and

WHEREAS, the parties mutually desire to extend the term of the Agreement; and

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Agreement is amended as follows:

- 1. The above recitals are true and correct and are incorporated herein.
- 2. The term of the Agreement is hereby extended on a month to month basis, for a term not to exceed three (3) months. The monthly rate of \$16,050 remains unchanged.
- 3. Except as provided herein, all other terms and conditions of the Agreement are hereby confirmed. The Agreement and this Amendment No. 2 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.
