

RESOLUTION NO. 08-20

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, APPROVING AGREEMENTS WITH A ONE FIRE EQUIPMENT, INC., BENNETT FIRE PRODUCTS CO., INC., FISHER SCIENTIFIC CO., LLC, MUNICIPAL EMERGENCY SERVICES, INC., MUNICIPAL EQUIPMENT CO., LLC, NORTH AMERICAN FIRE EQUIPMENT CO., INC., TEAM EQUIPMENT, INC., TECHNICALRESCUE.COM, INC., AND TEN-8 FIRE EQUIPMENT, INC.; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY AMENDMENTS AND/OR RENEWALS AND TAKE ALL ACTIONS NECESSARY TO EFFECTUATE THIS AGREEMENT; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach ("City") is authorized to enter into agreements to provide services, programming, and products in accordance with its Charter; and

WHEREAS, the City desires to procure fire equipment parts, supplies, and services from Contractors, utilizing existing contract prices provided to the Lake County, Florida pursuant to its Solicitation No 17-0606; and

WHEREAS, the City desires to enter into agreements with A One Fire Equipment, Inc.; Bennett Fire Products Co., Inc.; Fisher Scientific Co., LLC; Municipal Emergency Services, Inc.; Municipal Equipment Co., LLC; North American Fire Equipment Co., Inc.; Team Equipment, Inc.; Technicalrescue.com, Inc.; and Ten-8 Fire Equipment, Inc., for fire equipment, parts, supplies and services; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

Section 1. The foregoing recitals are hereby affirmed and ratified.

The City Commission of the City of Delray Beach has reviewed and hereby approves these Agreements between the City and: A One Fire Equipment, which is attached to this Resolution as Exhibit A; Bennett Fire Products Co., Inc., which is attached to this Resolution as Exhibit B; Fisher Scientific Co., LLC, which is attached to this Resolution as Exhibit C; Municipal Emergency Services, Inc., which is attached to this Resolution as Exhibit D; Municipal Equipment Co., Inc, which is attached to this Resolution as Exhibit E; North America Fire Equipment Co., Inc., which is attached to this Resolution as Exhibit F; Team Equipment, Inc., which is attached to this Resolution as Exhibit G; TechnicalRescue.com, Inc., which is attached to this Resolution as Exhibit H; Ten-8 Fire Equipment, Inc., which is attached to this Resolution as Exhibit I.

Section 3. The City Commission authorizes the City Manager to execute any amendments and/or renewals thereto and take any other actions necessary to effectuate these Agreements.

Section 4. This Resolution shall become effective immediately upon adoption.
