City of Lantana Population: 11,867	Any person who is a duly registered elector of the town may become a candidate for any elective office by presenting to the town clerk a petition subscribed by at least one (1) percent of the total registered electors of the town . Upon presenting such petition, the person shall be entitled to have his name placed upon the ballot for such office. Such petition must be filed with the town clerk no earlier than the first business day in December and no later than 4:30 p.m. on the tenth business day in December.	Pay such fees as may be required by law.
Palm Beach Gardens Population: 56,284	<p>A candidate shall obtain the signatures of a number of qualified electors equal to at least one (1) percent of the total number of registered electors of the city as shown by the certified election results for the last preceding municipal election,</p> <p>The mayor shall be compensated at the rate of \$24,000.00 per year...</p> <p>Each member of the city council shall be compensated at the rate of \$22,000.00 per year</p>	<p>The amount of the filing fee is 3% percent of the annual salary of the office.
