THIS AMENDMENT NO. 2 to the School Crossing Guards Agreement dated September 15, 2015 (Agreement), by and between City of Delray Beach, a municipal corporation of the State of Florida (City), and Staffing Connection D/B/A Action Labor of Florida (Contractor), a Florida corporation, is entered this ____ day of _____, 20__.

WITNESSETH:

WHEREAS, on September 15, 2015, the City Commission awarded a three-year agreement to Contractor for school crossing guard services, with the option to renew for two additional two-year periods; and

WHEREAS, on June 1, 2018, the City exercised its first option to renew the Agreement for two years and the parties executed Amendment No. 1 to the School Crossing Guards Agreement; and

WHEREAS, the first renewal term of the Agreement expires on September 14, 2020. Contractor has continued to provide services in accordance with the terms and conditions of the Agreement; and

WHEREAS, the City desires to continue to procure these services from Contractor and exercise the final two-year option to renew the Agreement through September 14, 2022; and

WHEREAS, Contractor agrees to continue to provide services to the City in accordance with the terms and conditions of the Agreement; and

WHEREAS, the City determines that it is in the best interest of the City to approve Amendment No. 2 to renew the Agreement through September 14, 2022.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Agreement is amended as follows:

1. The above recitals are true and correct and are incorporated herein.
2. This Amendment No. 2 extends the Agreement, under the same terms and conditions, for the period of September 15, 2020 through September 14, 2022.
3. Except as provided herein, all other terms and conditions of the Agreement and Amendment No. 1 remain in full force and effect and are hereby ratified and confirmed. The Agreement, Amendment No. 1, and this Amendment No. 2 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.
