## WITNESSETH:

WHEREAS, on September 15, 2015. the City Commission awarded a three-year agreement to Contractor for school crossing guard services, with the option to renew for two additional two-year periods; and

WHEREAS, on June 1, 2018, the City exercised its first option to renew the Agreement for two years and the parties executed Amendment No. 1 to the School Crossing Guards Agreement; and

WHEREAS, the first renewal term of the Agreement expires on September 14, 2020. Contractor has continued to provide services in accordance with the terms and conditions of the Agreement; and

WHEREAS, the City desires to continue to procure these services from Contractor and exercise the final two-year option to renew the Agreement through September 14, 2022; and

WHEREAS, Contractor agrees to continue to provide services to the City in accordance with the terms and conditions of the Agreement; and

WHEREAS, the City determines that it is in the best interest of the City to approve Amendment No. 2 to renew the Agreement through September 14, 2022.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Agreement is amended as follows:

- 1. The above recitals are true and correct and are incorporated herein.
- 2. This Amendment No. 2 extends the Agreement, under the same terms and conditions, for the period of September 15, 2020 through September 14, 2022.
- 3. Except as provided herein, all other terms and conditions of the Agreement and Amendment No. 1 remain in full force and effect and are hereby ratified and confirmed. The Agreement, Amendment No. 1, and this Amendment No. 2 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.
