The undersigned proposes to provide additional professional services necessary to complete the following work: Certificate of Appropriateness and Site Plan Application, Plans, Submittals, Resubmittals and Reimbursables as required for receipt of a Site Plan Certification from the Development Services Department for the redevelopment of the existing improvements located at 98 NW 5<sup>th</sup> Avenue. The above additional services are required due to the complete modifications to a Site Plan Application submitted on 8/01/2019 responsive to the First Amendment entered into on July 9, 2019. Note, this previous Site Plan was based on a program developed with Delray Beach Staff. Said Program changed significantly thus requiring a redesign of the Site Plan. Besides the redesigned Site Plan that removed on-site surface parking, relocated the proposed Elevator Tower and dedicated additional ROW, these proposed Additional Services include a Change of Use as well as satisfaction of Development Standards for a property in a Historic District. The Additional Services include additional Architectural, Civil Engineering, Traffic Engineering, Photometrics, Landscape Architecture and Surveying in response to TAC Comments and in support of the Justification Statement for compliance with Standards for Rehabilitation. Also, a Cost Estimate for Construction, 12 Site Visits during Construction and Assistance reviewing Close-Out Documents will be provided as part of the additional services.
