The request before the board is a Class I Site Plan Modification associated with the painting of murals on the existing loading dock roll up doors on the west side of the warehouse.

Built in 1965, the metal warehouse has nine loading docks with roll up doors with a total of 4,344 sq. ft, (1944 sq. ft. warehouse and 2400 sq. ft. of office.)

The request before the board is a Class I Site Plan Modification associated with the painting of murals on the existing loading dock roll up doors on the west side of the warehouse.

The project is called "Delray Doors". The murals were painted during the pandemic through a collaboration by the owner of the building, Billy Himmelrich and Galera Collective. Galera Collective was founded in 2016 by Glayson LeRoy. The organization works to support artist by supporting local creatives in displaying their work and sold by marketing them across South Florida. Galera Collective has painted murals in Delray at 524 W Atlantic Avenue and 601 W Atlantic Avenue.

### **Architectural Elevation Analysis:**

- 3. The proposed structure, or project, is in harmony with the proposed developments in the general area, with the Comprehensive Plan, and with the supplemental criteria which may be set forth for the Board from time to time.


