A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, RATIFYING AGREEMENTS WITH RED WING SHOE STORE AND SAFETY SHOE DISTRIBUTORS, LLP. PREVIOUSLY EXECUTED BY THE CITY MANAGER PURSUANT TO THE EMERGENCY PURCHASING AND PROCUREMENT PROCEDURES OUTLINED IN RESOLUTION 76-20 AS WELL AS CHAPTER 95 OF THE DELRAY BEACH CODE OF ORDINANCES; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach (City) is authorized to enter into agreements to provide services, programming and products in accordance with its Charter; and

WHEREAS, the City requires services for safety products and entered into agreements with Red Wing Shoe Store and Safety Shoe Distributors, LLP to obtain this service; and

WHEREAS, on March 13, 2020, the City of Delray Beach declared a local state of emergency due to the spread of the Novel Coronavirus Disease 2019 (COVID-19); and

WHEREAS, pursuant to the authority in Chapter 95 of the Delray Beach Code of Ordinances, the City Manager is authorized to execute the necessary agreements during the state of emergency where such expenditure does not exceed \$150,000.00; and

WHEREAS, on March 24, 2020, Resolution 76-20 was executed by the City Manager and later ratified by the City Commission, authorizing emergency purchasing and procurement procedures and suspending certain city codes, rules, and regulations related to purchasing and procurement; and

WHEREAS, pursuant to that authority, the City Manager executed the above-referenced agreement with Red Wing Shoe Store and Safety Shoe Distributors, LLP; and

WHEREAS, the City Commission deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Delray Beach and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

- <u>Section 1</u>. The foregoing recitals are hereby affirmed and ratified.
- Section 2. The City Commission of the City of Delray Beach hereby ratifies the Agreements between the City and Red Wing Shoe Store and Safety Shoe Distributors, LLP which is attached as Exhibit "A".
- Section 3. The City Commission authorizes the City Manager to execute any amendments and/or renewals thereto and take any other actions necessary to effectuate this Agreement.
 - <u>Section 4.</u> This Resolution shall become effective immediately upon adoption.
