Update:

Exterior lighting repairs made to ensure proper lighting for commerical building, bulbs and fixtures changed as needed.



Additional CRA Initiatives

- Monitoring ongoing repairs at both Carolyn Quince Court and LaFrance Apartment complexes. LaFrance property obtaining quotes for a roof replacement.
- 186 NW 5th Ave has been treated for termites and both 182 and 186 NW 5th Ave have signs of water damage, roof repairs pending.
- 186 NW 5th Ave recently had property damage caused by a brick being thrown at the front glass door. An investigation is ongoing with Delray PD, the door is pending glass replacement.
