

RESOLUTION NO. 44-21

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, DESIGNATING A PORTION OF BRYAN BOULEVARD, A PRIVATE RIGHT-OF-WAY WHICH SPANS FROM WEST LINTON BOULEVARD TO SOUTH MILITARY TRAIL, TO HEROES WAY, AS LOCATED IN EXHIBIT "A"; AND PROVIDING FOR AN EFFECTIVE DATE, AND FOR OTHER PURPOSES.

WHEREAS, the City of Delray Beach, Florida ("the City") received an application to designate as Heroes Way a private right-of-way owned by Tenant Healthcare Corp., National Medical Enterprises, Inc., and Delray Medical Center, Inc., ("Owners") currently known as Bryan Boulevard, which spans from West Linton Boulevard to South Military Trail, as located in Exhibit "A"; and

WHEREAS, Owners seek to designate Bryan Boulevard as Heroes Way to honor all doctors, nurses, front-line workers, and first responders; and

WHEREAS, there are no addresses which utilize Bryan Boulevard; therefore, designating Bryan Boulevard as Heroes Way will not result in the need to change any property addresses; and

WHEREAS, the City Code of Ordinances ("Code") Section 102.25 states, it shall be the duty of the City Planning and Zoning Board to recommend the designation of names and numbers for streets and it shall be the duty of the Commission of the City to finally determine the designation of names and numbers for streets; and

WHEREAS, pursuant to Code Section 102.25, the Planning and Zoning Board formally reviewed the request at a public hearing on February 22, 2021, and voted \_ to \_ to recommend \_\_\_\_\_ redesignating Bryan Boulevard to Heroes Way; and

WHEREAS, the City Commission of the City of Delray Beach, Florida, deems it to be in the best interest of the City to designate Bryan Boulevard, which spans from West Linton Boulevard to South Military Trail, as located in Exhibit "A", to Heroes Way.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELRAY BEACH, FLORIDA, AS FOLLOWS:

Section 1. That the above recitals are incorporated as if fully set forth herein.

Section 2. Bryan Boulevard, which spans from West Linton Boulevard to South Military Trail, as located in Exhibit "A", is now designated as Heroes Way.

Section 3. This Resolution shall take effect immediately upon its adoption.
