#### FISCAL YEAR 2020-2021 FUNDING INCENTIVE PROGRAMS SUMMARY

At the September 29, 2020 CRA Board Meeting, the board approved a budget amendment that included an increase to the CRA's economic development funding assistance programs. Funding assistance increased to a total of \$850,000 for fiscal year 2020-2021. Funding for the Curb Appeal Residential Improvement Program is \$150,000.

As of 3/11/2021, only the withheld balance in the amount of \$18,742.14 is remaining and can be disbursed following project completion. While improvements have begun, grantee continues to report delays due to a recent change of contractor. To ensure project completion within the bounds of the funding agreement, a second amendment is under consideration to extend the termination date to the end of the fiscal year. **Progress photos attached.**






