#### City Manager's response to prior public comments and inquiries

#### A.From the Public:

<u>Gayle Clark</u>, residing at 124 NE 7th Avenue, Delray Beach, called to protest the removal of eighty trees on the Sundy Village Property. She requested the Commissioners hold the developer accountable for their actions.

<u>Lisa Bonner</u>, residing at 50 East Road, Delray Beach, expressed she was not in favor of cutting down the trees on the Sundy Village Property because of their historic and aesthetic value. She requested the Commission to support historical and green spaces.

<u>Carolyn Patton</u>, residing at 1020 Cameron Road, Delray Beach, stated she has worked in Delray Beach and served on the Historic Preservation Board. She questioned whether the Historic Ordinances were being enforced. Ms. Patton suggested the Commission should investigate the situation and not allow the developers to remove the historic trees.

<u>Claudia Willis</u>, residing at 160 Marine Way, Delray Beach, voiced her concern that Tree Ordinance No. 19-17 and section 4.6.19. of the Land Development Regulations were not enforced. She believed Delray Beach was losing its "canopy" due to the trees that are being allowed to be cut down.

<u>LaToya Boone</u>, 507 SW 15th Avenue, Delray Beach, expressed her concerns about the trees that were recently cut down on the Sundy Village Property.

<u>Benita Goldstein</u>, residing at 302 NE 7th Avenue, Delray Beach, voiced her concern regarding negligence of protecting the City's historic buildings. She requested the Commission to hold developers accountable and to enforce the ordinances created to keep historic properties safe.

<u>Dwight Tidwell</u>, residing at 252 NE 17th Street, Delray Beach, expressed concern regarding the decision to allow a road extension to be built at the Delray Ridge Development instead of a pedestrian path.

<u>David Hopple</u> residing at 1700 SW 57th Avenue, Miami Beach Florida, voiced his concern regarding the dispute between Ric Man Construction and his company DIP Supply LLC.

<u>Merrily Nestler</u>, 7340 Amberly Lane, Unit 309, Delray Beach, advised the Commission that the Chamber of Commerce will not refund her deposit for the Delray Affair that was canceled.

DISCUSSION CONCERNING OFFICE OF INSPECTOR GENERAL INVESTIGATIVE REPORT 2019-004, "CITY OF DELRAY BEACH GRANTS PROGRAM" DATED FEBRUARY 16, 2021

#### **Body:** Background:

On February 16, 2021, the Office of Inspector General ("OIG") issued a report concerning its investigation into the City of Delray Beach Grants Program. According to the report, the OIG received a complaint in May 2019 regarding former employees, Michael Coleman ("Coleman") and Jamael Stewart ("Stewart"). The complaint alleged that (1) Coleman and Stewart caused disbursement of City grants to organizations that did not submit a required application, and/or that submitted applications were not reviewed by a committee designated by the City Manager;" (2) Coleman and Stewart "failed to avoid conflicts of interest between their personal interests and the City's interests;" (3) Stewart "solicited funds under false pretenses on behalf of a nonprofit for which he served as an officer/director;" and (4) Coleman "used a City purchasing card to buy trophies for Mr. Stewart and Mr. Stewart's cousin." The OIG found

support for 3 of the allegations. The OIG made 3 recommendations to assist the City in strengthening its controls over grants:

(1) Amend Policy GA-23; (2) Add language to the City's Check Request Form requiring a certification from the approver that they have not served as an officer, director, or employee of the organization receiving funds; and (3) Inform employees of updates to the ethics policy and require an acknowledgement for same.

The City concurred with these recommendations and has begun the process of implementing same. In addition, the OIG identified a \$140 purchase on the City's credit card by Mr. Coleman that should be recouped by the City as it did not constitute a public purpose. **Sponsors:** City Attorney Department
