 - A: I have been volunteering at Gumbo Limbo Nature Center as an Aquarium Guide since my Sophomore year of high school. I work at the four outdoor aquarium tanks teaching visitors about the exhibits and answering any questions they might have. Each session to volunteer is a four hour period. As I dedicated more time to volunteering, I became incredibly knowledgeable about the species in the tanks as well as what each tank represented in terms of a coastal ecosystem. Soon, I started teaching fellow volunteers about the tank inhabitants and the best ways to communicate with a wide diversity of visitors. I also have worked several special events for Gumbo Limbo including Sea Turtle Day, in which thousands of people pass through the exhibits, and "Halloween in the Garden", in which I helped as a face painter. This past summer I also helped the Sea Turtle Rehab program in a sea turtle hatchling release to send about 300 baby turtles off into the night sea for a second chance at survival. I worked to guide several visitors as well in this experience.

My responsibilities have now culminated into becoming the speaker for the Saturday 12:30 feeding presentation of the aquariums, giving a 30 minute talk about 40 to 250 people each week. I prepare frozen squid and krill to feed the animals, as well as monitor the water quality and animal health in each tank. This was a large undertaking that required many hours of learning how to be an Aquarist Assistant to the biologists and ecologists working at Gumbo Limbo.

Although not affiliated with Gumbo Limbo's volunteer program, I also have volunteered at Gumbo Limbo's Marine Research Facility with an FAU ecology professor, Dr. Koch, investigating how seaweed indicates the effects of climate change on coral reefs. In my feeding presentations, I proudly stand in a large crowd with the confidence knowing they look to me as a figure of expertise in marine life and environmental stewardship. I focus on sharing the small actions we can individually take to limit human impact on mangroves and coral reefs. Whether I'm explaining how certain (avoidable) sunscreen

chemicals strain the symbiotic relationship between corals and algae or speaking about local artificial reefs families can visit, I can feel the impact of my volunteer work. At the end of my speech, I often receive applause from the visitors. I can't help but smile when seeing how I am able to convey imperative issues while expressing something I'm passionate about to hundreds of people.

I will also hope to continue my volunteer work at Gumbo Limbo this summer working in the Sea Turtle Rehabilitation Center. While I am going to Columbia University next year for college, I am happy to maintain current with local issues and engage via online communications with the Board in addition to my breaks throughout the year when I can return home.

Mrs. Garden-Young was nice enough to not only respond so attentively to my concerns, but also told me about the Green Implementation Advisory Board opportunity.

I have been exposed me to the world of environmental stewardship, and in turn I am given a weekly chance to do the same to hundreds of people.
