# FIRST AMENDMENT TO THE PAINT-UP AND SIGNAGE FUNDING AGREEMENT THIS FIRST AMENDMENT TO THE PAINT-UP AND SIGNAGE FUNDING AGREEMENT ("First Amendment") is made and entered into as of the \_\_\_\_ day of \_\_\_\_\_\_, 2021, by and between the DELRAY BEACH COMMUNITY REDEVELOPMENT AGENCY, a public agency created pursuant to Section 163, Part III, Florida Statutes, (hereinafter referred to as the "CRA"), and ADVANCED CHIROPRACTIC OF SOUTH FLORIDA, LLC, a Florida limited liability company (hereinafter referred to as "GRANTEE").

#### WITNESSETH:

**WHEREAS**, the CRA and the GRANTEE previously entered into a Paint-up and Signage Funding Agreement dated June 10, 2021, (the "Original Agreement"); and

**WHEREAS**, the CRA and GRANTEE desire to enter into a First Amendment to the Original Agreement in order to amend the scope of the project to include both exterior painting and signage, and to correct the recommended award amount not to exceed Four Thousand Four Hundred Twenty Five and 00/100 Dollars (\$4,425.00).

**NOW THEREFORE**, in consideration of the promises, mutual covenants, provisions, and undertakings hereinafter contained, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. That the recitals set forth above are true and correct and are incorporated herein by reference.

2. That Section 4.02 of the Original Agreement is hereby amended as follows:

4.02 Reimbursement is at the approved award rate of 50% of eligible exterior painting <u>and signage costs</u>. Pursuant to the Program Guidelines, the authorized expenses eligible for reimbursement is an amount not to exceed Three Thousand Eight Hundred Forty One and 00/100 Dollars (\$3,841.00) Four Thousand Four Hundred Twenty Five and 00/100 Dollars (\$4,425.00).

3. That Exhibit "A" of the Original Agreement is replaced with the attached Exhibit "A".

4. That except as amended herein, the CRA and GRANTEE ratify, approve, and reaffirm the terms of the Original Agreement, and the Original Agreement shall remain in full force and effect, except as amended herein.

5. In the event of any conflict or ambiguity by and between the terms and provisions of the Original Agreement, and this First Amendment, this First Amendment shall control to the extent of any such conflict or ambiguity.
