CITY OF DELRAY BEACH AMENDMENT NO. 1 TO AN AGREEMENT WITH CANON SOLUTIONS AMERICA, INC. FOR MULTIFUNCTION DEVICE EQUIPMENT, SUPPLIES, SOFTWARE AND SERVICE SOLUTIONS

THIS AMENDMENT NO. 1 to the Master Contractor/Service Agreement for multifunction device equipment, supplies, software and service solutions, dated April 2, 2020, by and between the City of Delray Beach, a municipal corporation of the State of Florida (hereinafter referred to as "City"), and Canon Solutions America, Inc. (hereinafter referred to as "Contractor"), a New York corporation, authorized to do business in the State of Florida, is entered into this _____ day of August, 2021.

WITNESSETH:

WHEREAS, on April 2, 2020, utilizing a County of DuPage five-year agreement (hereinafter referred to as the "Master Agreement"), the City entered into an agreement with Canon Solutions America, Inc., for multifunction device equipment, supplies, software and service solutions (hereinafter referred to as the "Agreement"); and

WHEREAS, the original Agreement term was through September 30, 2021; and

WHEREAS, the City desires to extend the term of the Agreement in accordance with the terms of the Master Contract; and

WHEREAS, Contractor agrees to provide multifunction device equipment, supplies, software and service solutions in accordance with the agreement.

NOW, THEREFORE, the parties do agree that the Agreement is amended as follows:

- 1. The above recitals are true and correct and are incorporated herein.
- 2. The Agreement is hereby amended to terminate on September 30, 2023.
- 3. Except as provided herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby confirmed. The Agreement and this Amendment No. 1 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.
