

LEGAL DESCRIPTION:

THE NORTH 5 FEET OF THE WEST 15 FEET OF PARCEL OF LAND IN SECTION 8, TOWNSHIP 46 SOUTH, RANGE 43 EAST, MORE PARTICULARLY DESCRIBED AS FOLLOWS:
