We would like to add new signage so customers can identify our location with ease. We would also like to add surveillance cameras and additional lighting to ensure customer safety. The air conditioning, electrical and plumbing need to be replaced to meet current building codes and standards. An energy efficient air conditioning unit will help lower our electric bill as well as lower the amount of carbon dioxide and other pollutants emitted in atmosphere.							
As part of our beautification efforts, we would like to paint and repair the existing walls, and add flooring since there is only the original concrete slab. We would also like to replace the current countertop, which was designed specifically for the previous business, a dry cleaner.
